AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, on the 28th day of March, 2002, George D. Ramey and Nancy Lou Ramey, Husband and Wife As Joint Debtors executed to UNION STATE BANK, WINTERSET, IOWA a certain note dated on that day for the sum of Fifty Six Thousand and 00/100---(\$56,000.00) DOLLARS, payable on the 23rd day of March, A.D., 2008, and at the same time the said, George D. Ramey and Nancy Lou Ramey executed to the said UNION STATE BANK a mortgage bearing even date with the said note, upon real estate described in said mortgage as security for payment of said note, which mortgage was recorded in the office of the Recorder of Madison County, Iowa, on the 1st day of April, A.D., 2002, at 12:09 o'clock P. M., in Book 2002 of Mortgages, on Page 1508 and,

Whereas, George D. Ramey and Nancy Lou Ramey is now the owner of the real estate described in said Mortgage and,

Whereas, there remains unpaid on the principal of said mortgage the sum of Forty-five Thousand Forty One and 25/100-----(\$45,041.25) DOLLARS, and,

Whereas, the said makers have agreed with the holder of said mortgage to extend the time of payment thereon,

NOW THEREFORE, the said George D. Ramey and Nancy Lou Ramey hereby agrees to pay on the 28th of March A.D., 2008, the principal sum of Forty-five Thousand Forty One and 25/100-----(\$45,041.25) DOLLARS, remaining unpaid on the said note and mortgage, \$419.84 is to be paid monthly beginning April 23, 2008 and each month thereafter until March 23, 2011 when unpaid balance is due with interest from March 28 2008 at the rate of 6.95 per cent per annum payable monthly beginning on the 23rd day of April and each month thereafter, with both principal and interest payable at UNION STATE BANK, WINTERSET, IOWA; and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest as here in before stated from March 28 2008 until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of \_\_\_\_\_ per cent per annum.
