This AGREEMENT is made and entered into this day of April 9-08, by and between the MADISON SWCD County Soil and Water Conservation District, herein called DISTRICT, and RON SCHMITT, herein called RECIPIENT. WITNESSETH:

DISTRICT and RECIPIENT hereby agree that this covenant is executed to satisfy the requirements of lowa Code Section 161A.7(16) and should be interpreted in a manner that promotes the policies of Chapter 161A of the lowa Code. Section 161A.7(16) requires this covenant as a condition for receiving DISTRICT financial incentive assistance and provides that the owner, present or future, of the property herein described is personally liable through this AGREEMENT if the soil and water conservation practice herein named is not maintained or is removed, altered or modified while this AGREEMENT is effective.

The RECIPIENT hereby acknowledges the receipt of FARMS Agreement No. #5322 in the amount of \$2,880.00 as reimbursement for partially or completely financing the herein named soil and water conservation practice on Otr. <u>NW1/4NE1/4NE1/4ANDW1/2NE1/4SE1/4ANDW1/2NE1/4NE1/4SE1/4ANDW1/2SE1/4NE1/4SE1/4OF Sec.</u> 20 Township Douglas Tier T76N Range R28W County Madison, in the State of Iowa.

RECIPIENT hereby agrees that no action shall be taken by the RECIPIENT or his/her agents or successors to remove, alter or modify any soil and water conservation practice herein named for 20 years from the date of the AGREEMENT unless prior written authorization is obtained from the District and incorporated into this AGREEMENT.

RECIPIENT hereby agrees that if any unauthorized removal, alteration or modification of the soil and water conservation practices herein named occurs during the term of this AGREEMENT, RECIPIENT will repair or reconstruct the practices to their original as-built design specifications at RECIPIENT'S own expense. In lieu of repairing or reconstructing the practices. DISTRICT, at the sole discretion, may allow RECIPIENT or RECIPIENT'S successors to refund to the lowa Division of Soil Conservation the entire amount of the financial incentive payment received by RECIPIENT.

DISTRICT and RECIPIENT hereby agree that if RECIPIENT makes a refund of all money received under this AGREEMENT to the DIVISION that the AGREEMENT is cancelled and that no costs of cancellation shall be charged to either party.

RECIPIENT hereby agrees to notify any prospective purchaser of the property herein described of the landowner's obligations created by this AGREEMENT and Section 161A.7(16) of the Iowa Code and Section 27-10.31 of the lowa Administrative Code before legal or equitable title to any portion of this property is
