

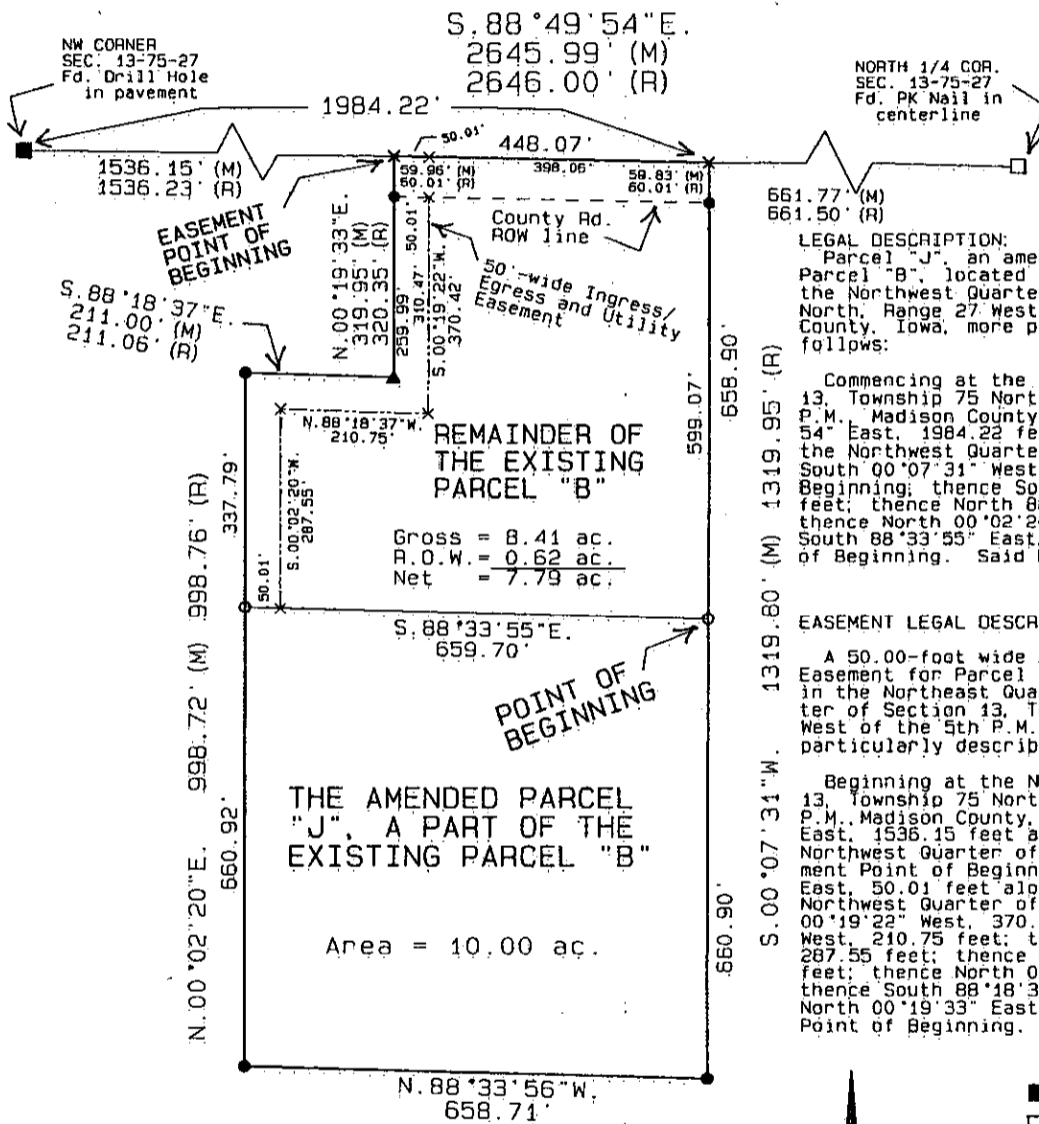

AN AMENDED PLAT OF SURVEY FOR ROBBIE D. & KAROLYN M. BAKER, LOCATED IN THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 13, TOWNSHIP 75 NORTH, RANGE 27 WEST OF THE 5th P.M., MADISON COUNTY, IOWA. THIS PLAT WAS AMENDED TO REPLACE THE PLAT FILED ON SEPTEMBER 2, 2005 IN BOOK 2005, PAGE 4266 AT THE MADISON COUNTY RECORDER'S OFFICE BECAUSE THE OWNERS CHANGED THE LOCATION OF THEIR FUTURE HOUSE SITE.



LEGAL DESCRIPTION:
Parcel "J", an amended plat which is a part of Parcel "B", located in the Northeast Quarter of the Northwest Quarter of Section 13, Township 75 North, Range 27 West of the 5th P.M., Madison County, Iowa, more particularly described as follows:

Commencing at the Northwest corner of Section 13, Township 75 North, Range 27 West of the 5th P.M., Madison County, Iowa; thence South 88° 49' 54" East, 1984.22 feet along the North line of the Northwest Quarter of said Section 13; thence South 00° 07' 31" West, 658.90 feet to the Point of Beginning; thence South 00° 07' 31" West, 660.90 feet; thence North 88° 33' 56" West, 658.71 feet; thence North 00° 02' 20" East, 660.92 feet; thence South 88° 33' 55" East, 659.70 feet to the Point of Beginning. Said Parcel contains 10.00 acres.

EASEMENT LEGAL DESCRIPTION:

A 50.00-foot wide Ingress/Egress & Utility Easement for Parcel "J" of Parcel "B", located in the Northeast Quarter of the Northwest Quarter of Section 13, Township 75 North, Range 27 West of the 5th P.M., Madison County, Iowa, more particularly described as follows:

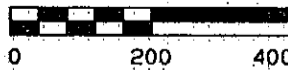
Beginning at the Northwest corner of Section 13, Township 75 North, Range 27 West of the 5th P.M., Madison County, Iowa; thence South 88° 49' 54" East, 1536.15 feet along the North line of the Northwest Quarter of said Section 13 to the Easement Point of Beginning; thence South 88° 49' 54" East, 50.01 feet along the North line of the Northwest Quarter of said Section 13; thence South 00° 19' 33" West, 319.95 feet; thence North 88° 18' 37" West, 210.75 feet; thence South 00° 02' 20" West, 287.55 feet; thence North 88° 33' 55" West, 50.01 feet; thence North 00° 02' 20" East, 337.79 feet; thence South 88° 18' 37" East, 211.00 feet; thence North 00° 19' 33" East, 319.95 feet to the Easement Point of Beginning.
