## AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, on the 15th day of April, 1994, Paul B. Nardini, A Single Person executed to UNION STATE BANK, WINTERSET, IOWA a certain note dated on that day for the sum of One Hundred Fifty Thousand and no/100------(\$150,000.00) DOLLARS, payable on the 1st day of April A.D., 1999, and at the same time the said Paul B. Nardini executed to the said UNION STATE BANK a mortgage bearing even date with the said note, upon real estate described in said mortgage as security for payment of said note, which mortgage was recorded in the office of the Recorder of Madison County, Iowa, on the 18th. Day of April, 1994 A.D., at 1:46 o'clock P. M., in Book 171 of Mortgages, on page 741 and,

Whereas <u>Paul B. Nardini</u> is now the owner of the real estate described in said Mortgage and, Whereas, there remains unpaid on the principal of said mortgage the sum of <u>Forty Thousand Four Hundred Fifty Dollars and</u>

47/100 -----(\$40, 450.47) <u>DOLLARS and</u>,

Whereas, the said <u>makers</u> have agreed with the holder of said mortgage to extend the time of payment thereon, NOW THEREFORE, the said <u>Paul B. Nardini</u>, hereby agrees to pay on the <u>Ist</u> day of <u>April</u>, A.D., <u>2008</u>, the principal sum of <u>Forty Thousand Four Hundred Fifty Dollars and 47/100 ------(\$40, 450.47) DOLLARS and,</u>

remaining unpaid on the said note and mortgage, \$12,010.09 is to be paid annually beginning April 1, 2009 and each year thereafter until April 1, 2012 when the unpaid balance is due, with interest from April 4, 2008 at sthe-rate.of\_7-25.per.cent-per-annum-due-on-annually—beginning-on-the-1st.day-of-April-1-2009 and each year thereafter, with both principal and interest payable at UNION STATE BANK, WINTERSET, IOWA; and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid\_on said mortgage, and the interest as here in before stated from April 4, 2008 until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of \_\_\_\_\_\_ per cent per annum.
