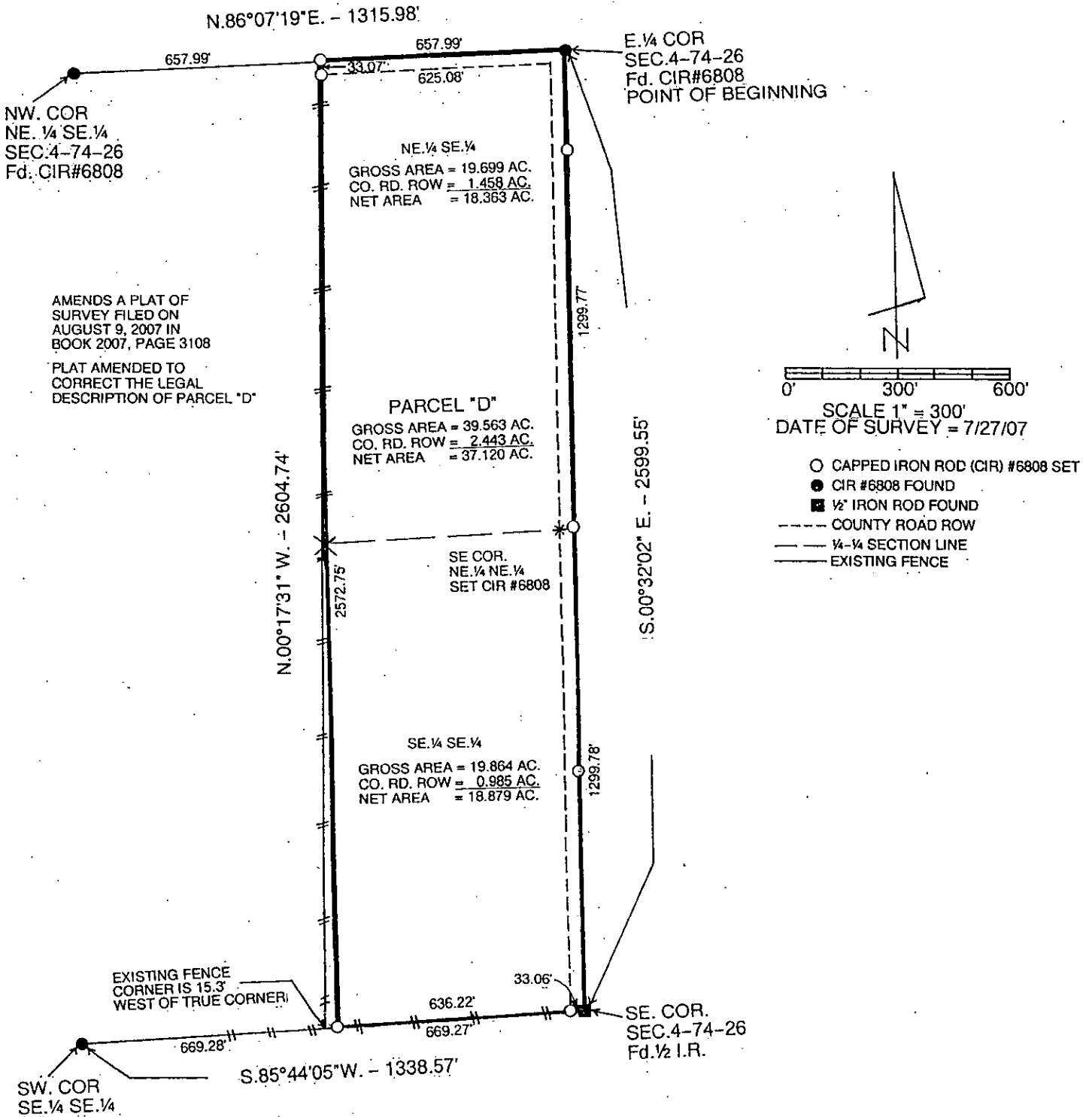

Beginning at the East Quarter corner of Section 4, Township 74 North, Range 26 West of the 5<sup>th</sup> P.M., Madison County, Iowa thence South 00°32'02" East 2599.55 feet to the Southeast Corner of said Section 4; thence South 85°44'05" West 669.27 feet along the South line of the Southeast Quarter of the Southeast Quarter of said Section 4; thence North 00°17'31" West 2604.74 feet along the West line of the East one-quarter of the Southeast Quarter of said Section 4 to a point on the North line of the Northeast Quarter of the Southeast Quarter of said Section 4; thence North 86°07'19" East 657.99 feet to the Point of Beginning containing 39.563 acres including 2.443 acres of County Road right-of-way.
