I hereby certify that title to the following described real estate has been changed to or established in STEVEN K. RADAKOVICH, to-wit:

a. AN UNDIVIDED ONE-HALF INTEREST IN AND TO:

All that part of the Southwest Quarter (¼) of Section Four (4) lying and being North of the main line of the Chicago, Rock Island and Pacific Railway Company right of way, Township 77 North, Range 28 West of the 5<sup>th</sup> P.M., Madison County, Iowa.

b. AN UNDIVIDED ONE-HALF INTEREST IN AND TO:

The South 1410 feet and the East 680 feet of the North 710 feet of the South 2120 feet of all that part of the Northwest Quarter (¼) of Section Nine (9) lying East of the quarry spur of the Chicago, Rock Island and Pacific Railway Company as the same runs through said quarter section, Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5<sup>th</sup> P.M., Madison County, Iowa.

c. AN UNDIVIDED ONE-HALF INTEREST IN AND TO:

All that part of the South Half ( $\frac{1}{2}$ ) of the Southwest Quarter ( $\frac{1}{4}$ ) of Section Three (3) lying South of the Chicago, Rock Island and Pacific Railway Company right-of-way, Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa.

d. AN UNDIVIDED ONE-HALF INTEREST IN AND TO:

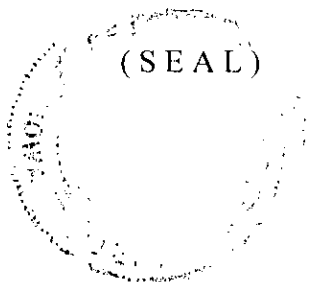
The Southwest Quarter ( $\frac{1}{4}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of Section Nine (9); and that part of the Northeast Quarter ( $\frac{1}{4}$ ) of Section Nine (9) with boundaries as follows: Commencing at the Northwest corner of the Northeast Quarter ( $\frac{1}{4}$ ) of Section 9; thence South 10 rods along the West line of the Northeast Quarter ( $\frac{1}{4}$ ) of said Section Nine (9) to the Southwest corner of the cemetery, which is the point of beginning; thence East 16 rods to the Southeast corner of the cemetery; thence North 10 rods along the East line of the cemetery to the North line of said Section Nine (9); thence East 610 feet along the North line of said Section Nine (9); thence South 580 feet along a fenceline to a point which is 430 feet West of the East line of the Northwest Quarter ( $\frac{1}{4}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of said Section Nine (9); thence Southeasterly 685 feet to a point on the East-West fenceline 165 feet West of the East line of the Northwest Quarter ( $\frac{1}{4}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of said Section Nine (9), said fence is 1210 feet South of the North line of the Northeast Quarter ( $\frac{1}{4}$ ) of said Section Nine (9); thence East 165 feet along said fenceline to the East line of the Northwest Quarter ( $\frac{1}{4}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of said Section Nine (9); thence South along said East line to the Southeast corner of the Northwest Quarter ( $\frac{1}{4}$ ) of the Northeast Quarter ( $\frac{1}{4}$ ) of said Section Nine (9); thence West to the Southwest corner of the Northwest Quarter ( $\frac{1}{4}$ ) of the

Northeast Quarter (1/4) of said Section Nine (9); thence North along the West line of the Northeast Quarter (1/4) of said Section Nine (9) to the point of beginning, containing 29.2 acres more or less. (References to the location of said fenceline are approximate and subject to survey); and the North 330 feet of the South 980 feet of the East Half (1/2) of the Northeast Quarter (1/4) of said Section Nine (9); and the South 650 feet of the East Half (1/2) of the Northeast Quarter (1/4) of said Section Nine (9), except a parcel described as follows: Commencing at the East Quarter corner of said Section Nine (9), thence along the South line of the Southeast Quarter (1/4) of the Northeast Quarter (1/4) of said Section Nine (9), south 90°00'00" West, 512.30 feet to the point of beginning; thence continuing along said South line, South 90°00'00" West 615.00 feet; thence North 00°00'00" East 568 feet; thence North 00°00'00" East 615.00 feet; thence South 00°00'00" West 568.00 feet to the point of beginning, said excepted parcel containing 8.019 acres, including 0.466 acres of county road right of way, Township Seventy-seven (77) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa.
