The Southwest Quarter of the Southwest Quarter (SW¼ SW¼) of Section Thirteen (13), Township Seventy-four (74) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa;

Parcel "C", being a tract of land located in part of the Southeast Quarter of the Southwest Quarter (SE¼ SW¼) of Section 13, Township 74 North, Range 28 West of the 5th P.M., Madison County, lowa, described as follows:
