## Addendum

1. Commencing at a point on the North line of the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of Section One (1), in Township Seventy-five (75) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, 26.64 rods West of the northeast corner thereof, running thence South 16 1/2 rods, thence East 3 rods, thence North 16 1/2 rods, thence West 8 rods to the place of beginning lying within and being a part of the City of Winterset, Iowa; and otherwise known as Lots Six (6) of the Subdivision of said Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) of said Section One (1).

The consideration for this transfer is less than Five Hundred Dollars (\$500.00); therefore, no Declaration of Value or Groundwater Statement is required.
