RESOLUTION SCHEDULING PUBLIC HEARING TO VACATE. CLOSE AND CONVEY A PORTION OF VINE STREET AND CERTAIN ALLEYS, ADJACENT TO THE SCHOOL GROUNDS FORMERLY OWNED BY THE INTERSTATE 35 COMMUNITY SCHOOL DISTRICT

WHEREAS, Larry F. Reynolds and Lucille B. Reynolds, husband and wife, are the record holders of title to the following described real estate, to-wit:

Lots One (1), Two (2), Three (3), Four (4), Five (5), Six (6), Seven (7), and Eight (8) in Block Four (4) of Hartman and Young's Addition to the Town of St. Charles, Madison County, Iowa; and

Beginning at a point 66 feet due North of the Northeast corner of Block Four (4) of Hartman and Young's Addition to the Original Plat of St. Charles, Madison County, Iowa, thence running West 16 rods and 10 feet to a point 66 feet due North of the Northwest corner of said Block Four (4) of said Hartman & Young's Addition, thence due North 20 rods and 51/2 feet, thence East 16 rods and 10 feet running parallel with the North side of Vine Street in St. Charles, Iowa, thence South 20 rods and 51/2 feet to the place of beginning, containing 2 acres, more or less;

WHEREAS, the foregoing real estate was formerly used as a public school facility by the Interstate 35 Community School District, a predecessor in the chain of title;

WHEREAS, the school grounds included a portion of Vine Street lying between Lumber Street and Cross Street and the alleys located in Block Four (4) of Hartman and Young's Addition to the Town of St. Charles, Madison County, Iowa;

WHEREAS, the foregoing portion of Vine Street and the alleys located within Block 4 are no longer used for any public purpose and are being maintained by the record holders of title to the adjoining real estate, namely, Larry F. Reynolds and Lucille B. Reynolds.

WHEREAS, Larry F. Reynolds and Lucille B. Reynolds have agreed to pay the costs of publication and will be responsible for the necessary document preparation by their attorney in connection with vacating, closing, and transferring the portion of Vine Street and the alleys located within Block 4 adjoining their real estate;

WHEREAS, the City Council of the Incorporated City of St Charles, Iowa, acting under the authority of Iowa Code Chapter 364 (2008) has authority to vacate, close and transfer the portion of Vine Street and the alleys located within Block 4, all of which are adjacent to the former school property as described above; and

WHEREAS, Iowa Code Chapter 364 (2008), as amended, provides that a City may not dispose of real property by gift except to a governmental body for a public purpose;

WHEREAS, the fair market value of said property does not exceed the cost of the legal fees necessary to complete said disposition; and

WHEREAS, vacating the portion of Vine Street and the alleys lying within Block 4 that are adjacent to the former school property as described above and transferring the same to the adjoining property owners is not a gift;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the Incorporated City of St. Charles, Madison County, Iowa, that the following portion of Vine Street and the alleys lying within Block 4 of Hartman and Young's Addition to the Town of St. Charles, Madison County, Iowa, be vacated, closed, and conveyed to Larry F. Reynolds and Lucille B. Reynolds, husband and wife, subject to the payment of publication costs, described as follows:
