AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, there remains unpaid on the principal of said mortgage the sum of Fifty-four Thousand Three Hundred Seventeen and 90/100-----(\$ 54,317.90) DOLLARS, and,

Whereas, the said makers have agreed with the holder of said mortgage to extend the time of payment thereon, NOW THEREFORE, the said Richard and Patricia McMichael hereby agrees to pay on the 31st day of December A.D., 1999, the principal sum of Fifty-four Thousand Three Hundred Seventeen and 90/100-----(\$54,317.90) DOLLARS, remaining unpaid on the said note and mortgage, \$5,329.63 is to be paid annually beginning on December 30, 2000, and each year thereafter until December 30, 2004 when unpaid balance is due with interest from <u>December 30, 1999</u> at the rate of <u>7.5</u> per cent per annum payable <u>Annually</u>, beginning on the <u>30th</u> day of December, 2000 and each year thereafter, with both principal and interest payable at UNION STATE BANK.
