and State of Iowa, do hereby sell and convey unto
said Beggy Mc Lee the following described real
estate situated in the County of Madison, in the State of Iowa,

to-wit:

Cemetery" located in the Southwest corner of the East
Half of the Northeast Quarter (1/4) of Section Thirteen
(13), Township Seven-seven (77) North of Range
Twenty-eight (28) West of 5th P.M., Madison County,
Iowa, and legally described as follows, to-wit:

Commencing at the Southwest corner of the East Half of
the Northeast Quarter (1/4) of Section Thirteen (13),
Township Seventy-seven (77) North of Range Twenty-eight
(28) West of 5th P.M., thence North Thirty-eight rods,
thence East Fifteen rods, thence South Thirty-eight
rods, thence West Fifteen rods to the place of
beginning,

to be used for cemetery purposes only, for the interment of the
