AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, on the 30th day of April, 2003, Gregory R. Breeding and Betsy Breeding Husband and Wife executed to <u>UNION STATE BANK</u>, <u>WINTERSET</u>, <u>IOWA</u> a certain note dated on that day for the sum of <u>Seventy</u> Thousand and no/100-----(\$70,000.00) DOLLARS, payable on the 27th day of October, A.D., 2003, and at the same time the said Gregory R. Breeding and Betsy Breeding executed to the said UNION STATE BANK a mortgage bearing even date with the said note, upon real estate described in said mortgage as security for payment of said note, which mortgage was recorded in the office of the Recorder of Madison County, Iowa, on the 1st day of May, A.D., 2003, at 12:50 o'clock P. M., in Book 2003 of Mortgages, on page 2504 and,

Whereas, Gregory R. Breeding and Betsy Breeding is now the owner of the real estate described in said Mortgage and,

Whereas, there remains unpaid on the principal of said mortgage the sum of Forty-nine Thousand Three Hundred Fifteen and 20/100-----(\$49,315.20) DOLLARS, and,

Whereas, the said makers have agreed with the holder of said mortgage to extend the time of payment thereon.

NOW THEREFORE, the said Gregory R. Breeding and Betsy Breeding hereby agrees to pay on the 21st day of April A.D., 2004, the principal sum of Forty-nine Thousand Three Hundred Fifteen and 20/100--------(\$49,315.20) DOLLARS, remaining unpaid on the said note and mortgage, interest payments are to be paid monthly beginning 5/21/04 and each month thereafter until October 18, 2004 when the unpaid balance is due, with interest from April 21, 2004 at the rate of 6.250 per cent per annum payable monthly beginning on the 21st day of May, 2004 and each month thereafter in each year thereafter, with interest payable at UNION STATE BANK, WINTERSET, IOWA; and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest as here in before stated from April 21, 2004 until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of _____ per cent per annum.
