## RELEASE AND SATISFACTION OF MORTGAGE

Whereas, Iowa Southern Utilities Company of Delaware entered into a Deed of Trust with Northern Trust Company and Harold H. Rockwell as Trustee on February 1, 1923 (the "1923 Indenture"); and

Whereas, the 1923 Indenture was amended by the Supplemental Indenture dated May 2, 1940 between Iowa Southern Utilities Company of Delaware and the Northern Trust Company and Sheldon A. Weaver as Trustees ("the 1940 Supplemental Indenture"), and by the Supplemental Indenture dated October 2, 1945 between Iowa Southern Utilities Company of Delaware and the Northern Trust Company and Sheldon A. Weaver as Trustees, (the "1945 Supplemental Indenture") (the 1923 Indenture, 1940 Supplemental Indenture and the 1945 Supplemental Indenture being collectively referred to as the "Indentures"); and

Whereas, Interstate Power and Light Company ("Company") as the successor in interest to Iowa Southern Utilities Company of Delaware, has conveyed certain property (the "Property") to J.P.Morgan Trust Company, National Association, as successor in interest to Bank One Trust Company, N.A., f/k/a The First National Bank of Chicago (the "Trustee" and successor to The Northern Trust Company), in trust to secure the payment by said Company of certain bonds described in the Indentures; and

Whereas, said Company has requested said Trustee to release the Property from the lien of the Indentures, and all of the terms and conditions of said Indentures with respect to the release of the Property from the lien thereof have been complied with;

Now, Therefore, in consideration of the premises and the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Trustee under the Indentures and not individually, does hereby release and quitclaim unto the Company all the right, title and interest of the Trustee under said Indentures and in and to the Property subject to the Indentures, as recorded in the Office of the County Recorder at the Book(s) and Page(s) on the schedule attached hereto.
