

AGREEMENT



This Agreement made and entered into by and between Jack E. Wildin and Janice A. Wildin, husband and wife herein after called Wildins and Kevin Morlan herein after called Morlan. Whereas Wildins have sold the following described real estate to Morlan:

It is therefore agreed as follows:


