101 WARRANTY DEED Revised January, 2000 An undivided one-half interest in and to said real estate commencing at the Southwest corner of Lot Six (6) in Block Seventeen (17) in the Original Town of Winterset, Madison County, Iowa, and running thence North 22 feet, thence East 70 feet, thence North 10 feet, thence East 50 feet, with all right, title and interest in and to the brick wall located on the North One-half of the South 2/3rds of Lot Six (6) commencing at a point 50 feet East of the Southwest corner thereof and running thence East 20 feet, thence North 10 feet, and all other wall or walls located on that part of the North 2/3rds of Lot Six (6) which adjoins the above described real estate.
