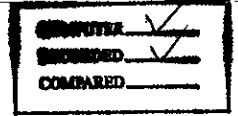

The undersigned hereby relinquishes all rights of dower, homestead and distributive share in and to the real estate. *for dissolution of marriage decree.*

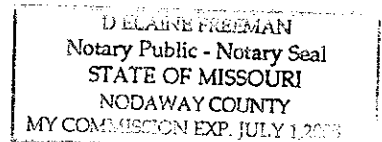

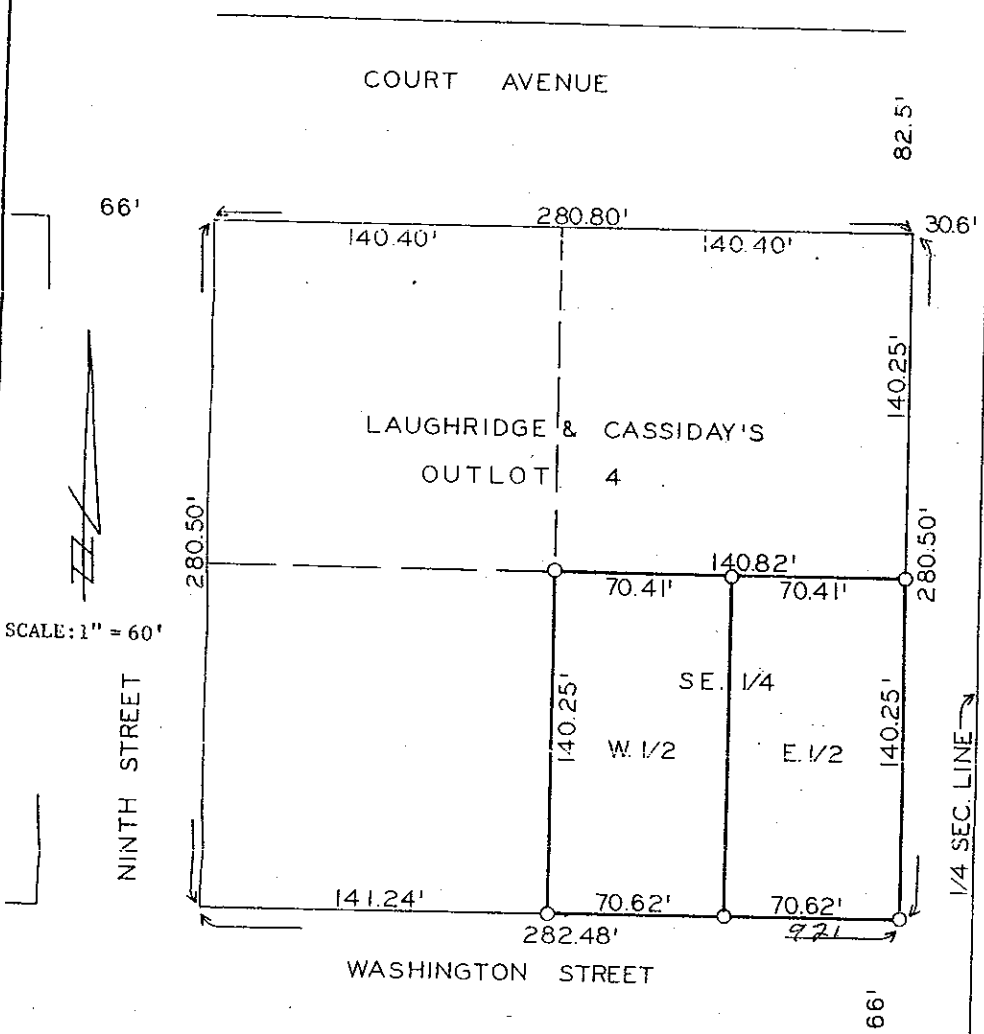

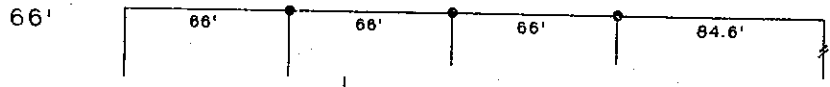
