

MODIFICATION OF REAL ESTATE CONTRACT

TA 50645
This modification of real estate contract made as of February 24, 2005, relates to and amends a certain contract effective August 1, 2001, between McCONNELL FARMS, LTD., an Iowa corporation (the Seller), and GARY W. CARSTENS AND BARBARA A. CARSTENS (the Buyers) for the purchase and sale of the following described real estate in Madison County, Iowa:

The East Half (E I/2) of the Northeast Quarter (NE 1/4) and the Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4) of Section 32, Township 74 North, Range 28 West of the 5th P. M.

The said contract was recorded under date of July 19, 2001, as Instrument No. 003144 in Book 2001 at Page 3144, Madison County land records.

The principal balance of the said contract is now paid down to \$65,000.00 and the Seller and Buyers have mutually agreed to the following modifications of the contract:

- 1. The final maturity of the contract is extended from March 1, 2005 to March 1, 2006.
- 2. Consideration to the Seller for this modification shall be a principal payment of \$8,000.00, an interest payment of \$5,200.00, and a recording fee of \$7.00, for a total of \$13,207.00 paid by the Buyers on or before March 8, 2005.
- 3. The Seller agrees to accept principal or interest payments on this contract in any amount at any time prior to the new maturity date of March 1, 2006.
- 4. In all other respects, all terms and conditions of the original contract will remain unchanged.
