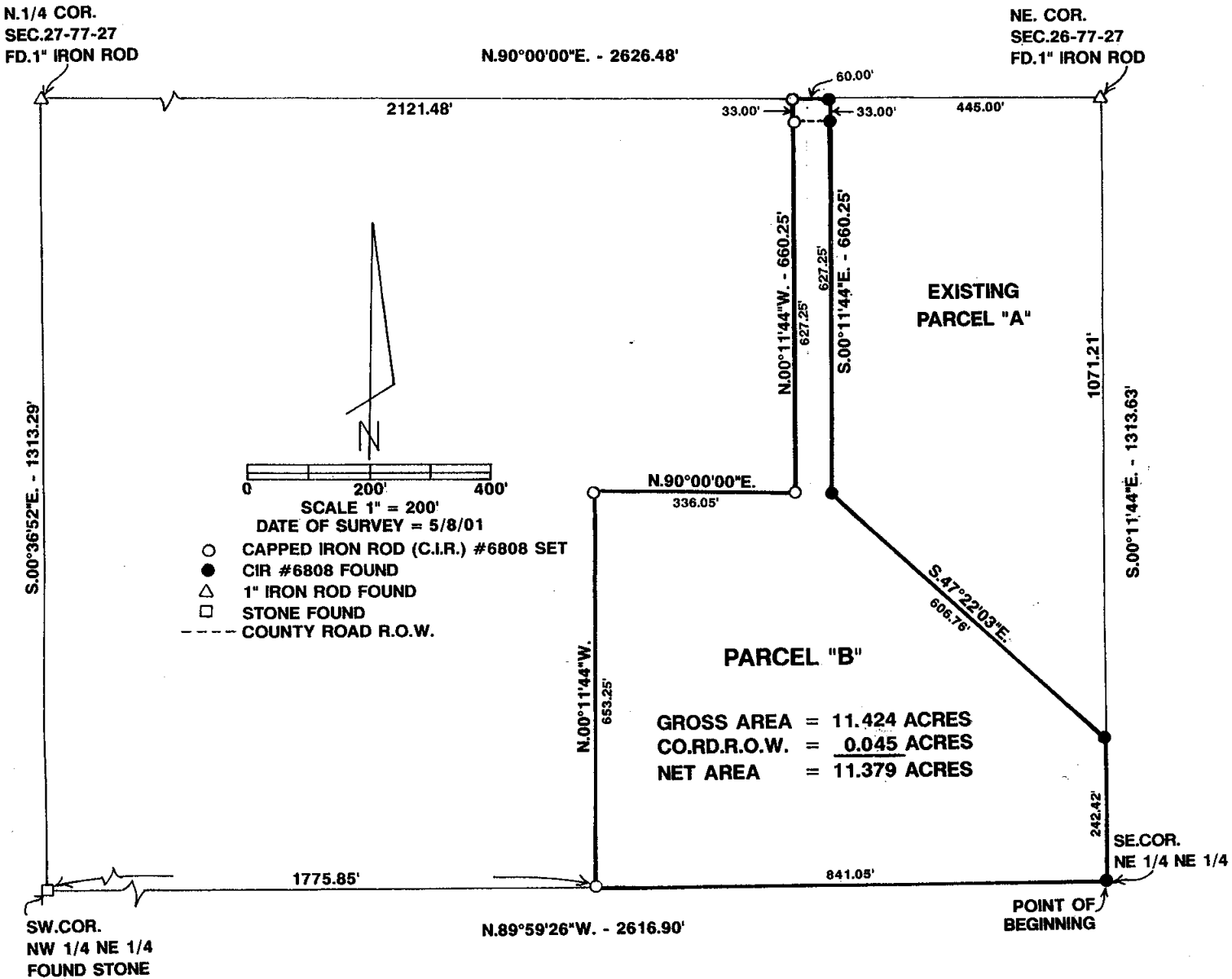

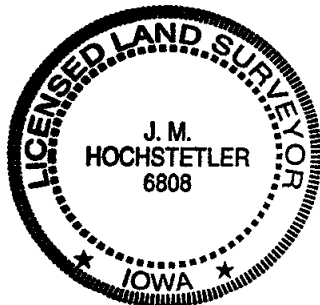

Beginning at the Southeast Corner of the Northeast Quarter of the Northeast Quarter of Section 26, Township 77 North, Range 27 West of the 5th P.M., Madison County, Iowa; thence North 89°59'28" West 841.05 feet along the South line of said Northeast Quarter of the Northeast Quarter; thence North 00°11'44" West 653.25 feet; thence North 90°00'00" East 336.05 feet; thence North 00°11'44" West 660.25 feet to a point on the North line of said Northeast Quarter of the Northeast Quarter; thence North 90°00'00" East 60.00 feet to the Northwest Corner of existing Parcel "A"; thence South 00°11'44" East 660.25 feet along the West line of existing Parcel "A"; thence South 47°22'03" East 606.76 feet to a point on the East line of said Northeast Quarter of the Northeast Quarter; thence South 00°11'44" East 242.42 feet to the Point of Beginning containing 11.424 acres including 0.045 acres of County Road right-of-way.
