AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, George R. Beltz, Ir. and Julie M. Bolton is now the owner of the real estate described in said mortgage and,

Whereas, the said makers have agreed with the holder of said mortgage to extend the time of payment thereon, NOW THEREFORE, the said George R. Beltz. Ir. and Julie M. Bolton hereby agrees to pay on the 17 day of September A.D., 2001, the principal sum of Twenty-seven Thousand Four Hundred Forty-three and 27/100 (\$27,443.27) DOLLARS, remaining unpaid on the said note and mortgage, \$391.24 is to be paid monthly beginning October 14, 2001 and each month thereafter until September 14, 2004 when the unpaid balance is due, with interest from September 17, 2001 at the rate of 15.0 per cent per annum payable monthly beginning on the 14th day of October, 2001 and each month thereafter, with both principal and interest payable at UNION STATE BANK, WINTERSET, IOWA; and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest as here in before stated from September 17, 2001 until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of ______ per cent per annum.
