STATE LAND OFFICE

The STATE OF IOWA, subject to conditions listed in this patent, hereby conveys to Jerrold J. Narland and Orlene N. Narland as joint tenants with full rights of survivorship and not as tenants in common, real estate in Madison County, Iowa, described as:

A parcel of land located in Lots 1, 2, 3, 4, 5, 6, 7 and 8 in Block 2 of Hornback and Bevington Addition to the City of Winterset, Madison County, Iowa, as shown on Plat of Survey attached hereto and by reference made a part hereof. Said parcel being more particularly described as follows:


Beginning at the SW Corner of Lot 5 of said Block 2; thence N0°09'27"E 247.28 feet along the west line of said Block 2; thence N89°49'05"E 230.25 feet; thence S33°25'51"E 59.18 feet to a point on the east line of said Block 2; thence S0°09'27"W 198.50 feet along said east line to the SE Corner of Lot 4 of said Block 2; thence S89°58'32"W 262.99 feet along the south line of said Block 2 to the Point of Beginning, excepting therefrom present established alley, said parcel contains 60,229 square feet.

CONDITIONS: Authority and consideration for issuance of this patent are stated in the certificate of the Right of Way Director of the Iowa Department of Transportation filed with the State Land Office as provided in Iowa Code Section 9G.6 (1999). This conveyance is subject to the conditions imposed by Iowa Code Sections 306.22, 306.23, 306.24, and 306.25 (1999), including the right of a utility association, company or corporation to continue in possession of a right of way in use at the time of the sale.




