Subordination Agreement

THIS SUBORDINATION AGREEMENT ("Agreement") is made this 26 December, 2001, between James S. Wright ("Borrower"), whether one or more, and The Chase Manhattan Bank as Indenture Trustee, Residential Funding Corporation, Attorney in Fact ("Subordinating Lender").
