

DESCRIPTION

That part of the Northeast Quarter of the Southwest Quarter and the Southeast Quarter of the Southwest Quarter of Section 15, Township 74 North, Range 26 West of the Fifth Principal Meridian, City of Truro, Madison County, lowa, described as follows:

Beginning at the southwest corner of the Northeast Quarter of the Southwest Quarter of said Section 15; thence on an assumed bearing of North 00 degrees 16 minutes 48 seconds West along the west line of said Northeast Quarter of the Southwest Quarter 247.68 feet to the south line of the City of Truro's lagoon access road, recorded in Book 101, Page 763, in the Madison County, lowa, Recorder's Office; thence North 85 degrees 39 minutes 05 seconds East along said south line 661.32 feet; thence South 84 degrees 56 minutes 38 seconds East along said south line 220.48 feet; thence South 00 degrees 02 minutes 10 seconds West 224.61 feet to the south line of said Northeast Quarter of the Southwest Quarter; thence South 00 degrees 02 minutes 10 seconds West 1309.95 feet to the south line of the Southeast Quarter of the Southwest Quarter of said Section 15; thence South 86 degrees 26 minutes 45 seconds West along said south line 370.33 feet; thence North 00 degrees 05 minutes 49 seconds West 120.00 feet; thence South 86 degrees 26 minutes 45 seconds West 506.00 feet to the west line of said Southeast Quarter of the Southwest Quarter; thence North 00 degrees 05 minutes 49 seconds West along said west line 1190.50 feet to the southwest corner of said Northeast Quarter of the Southwest Quarter and the point of beginning.

Said tract contains 30.00 acres and is subject to a City of Truro Street Easement over the southerly 0.28 acres thereof.
