Borrower is the mortgagor under this Security Instrument.

(C) "Lender" is UNION STATE BANK.....
Lender is a CORPORATION..... organized and existing under the laws of THE STATE OF IOWA..... Lender's address is P.O. BOX 110, 201 WEST COURT, WINTERSET, IA 50273..... Lender is the mortgagee under this Security Instrument.

(D) "Note" means the promissory note signed by Borrower and dated 04-02-2002..... The Note states that Borrower owes Lender FORTY ONE THOUSAND EIGHT HUNDRED AND NO/100..... (H) "Applicable Law" means all controlling applicable federal, state and local statutes, regulations, ordinances and administrative rules and orders (that have the effect of law) as well as all applicable final, non-appealable judicial opinions.

(I) "Community Association Dues, Fees, and Assessments" means all dues, fees, assessments and other charges that are imposed on Borrower or the Property by a condominium association, homeowners association or similar organization.

(J) "Electronic Funds Transfer" means any transfer of funds, other than a transaction originated by check, draft, or similar paper instrument, which is initiated through an electronic terminal, telephonic instrument, computer, or magnetic tape so as to order, instruct, or authorize a financial institution to debit or credit an account. Such term includes, but is not limited to, point-of-sale transfers, automated teller machine transactions, transfers initiated by telephone, wire transfers, and automated clearinghouse transfers.

(K) "Escrow Items" means those items that are described in Section 3.

3. Funds for Escrow Items. Borrower shall pay to Lender on the day Periodic Payments are due under the Note, until the Note is paid in full, a sum (the "Funds") to provide for payment of amounts due for: (a) taxes and assessments held by Lender which can strain priority over this security instrument as a lien or encumbrance required on the Property; (b) other items which provide for payment of amounts due for: (a) rents on the Property, if any; (c) premiums for any and all insurance payable by Borrower to Lender Section 5; and (d) Mortgage Insurance premiums, if any, or any sums payable by Borrower to Lender under Section 5; and (e) premiums for any and all insurance required on the Property; (f) fees, and Assessments, Fees, and Association Dues, at origination or at any time during the term of the Loan, Lender may require that Community Assessments shall be escrowed by Borrower, and such dues, fees and assessments shall be an Escrow item. To the extent that these items are Escrow Items, Borrower shall pay them in the manner provided in Section 3.

Borrower shall promptly discharge any lien which has priority over this Security Instrument unless Borrower: (a) agrees in writing to the payment of the obligation secured by the lien in a manner acceptable to Lender, but only so long as Borrower is performing such agreement; (b) contests the lien in good faith by, or defends against enforcement of the lien in, legal proceedings which in Lender's opinion operate to prevent the enforcement of the lien while those proceedings are pending, but only until such proceedings are concluded; or (c) secures from the holder of the lien an agreement satisfactory to Lender subordinating the lien to this Security Instrument. If Lender determines that any part of the Property is subject to a lien which can attain priority over this Security Instrument, Lender may give Borrower a notice identifying the lien. 5. Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. Lender may require Borrower to pay, in connection with this Loan, either: (a) a one-time charge for flood zone determination, certification and tracking services; or (b) a one-time charge for flood zone determination and certification services and subsequent charges each time remappings or similar changes occur which reasonably might affect such determination or certification. Borrower shall also be responsible for the payment of any fees imposed by the Federal Emergency Management Agency in connection with the review of any flood zone determination resulting from an objection by Borrower.

All insurance policies required by Lender and renewals of such policies shall be subject to Lender's right to disapprove such policies, shall include a standard mortgage clause, and shall name Lender as mortgagee and/or as an additional loss payee. Lender shall have the right to hold the policies and renewal certificates. If Lender requires, Borrower shall promptly give to Lender all receipts of paid premiums and renewal notices. Borrower can cure such a default and, if acceleration has occurred, reinstate as provided in Section 19, by causing the action or proceeding to be dismissed with a ruling that, in Lender's judgment, precludes forfeiture of the Property or other material impairment of Lender's interest in the Property or rights under this Security Instrument. The proceeds of any award or claim for damages that are attributable to the impairment of Lender's interest in the Property are hereby assigned and shall be paid to Lender.

All Miscellaneous Proceeds that are not applied to restoration or repair of the Property shall be applied in the order provided for in Section 2.

12. Borrower Not Released; Forbearance By Lender Not a Waiver. Extension of the time for payment or modification of amortization of the sums secured by this Security Instrument granted by Lender to Borrower or any Successor in Interest of Borrower shall not operate to release the liability of Borrower or any Successors in Interest of Borrower. Lender shall not be required to commence proceedings against any Successor in Interest of Borrower or to refuse to extend time for payment or otherwise modify amortization of the sums secured by this Security Instrument by reason of any demand made by the original Borrower or any Successors in Interest of Borrower. Any forbearance by Lender in exercising any right or remedy including, without limitation, Lender's acceptance of payments from third persons, entities or Successors in Interest of Borrower or in amounts less than the amount then due, shall not be a waiver of or preclude the exercise of any right or remedy.

13. Joint and Several Liability; Co-signers; Successors and Assigns Bound. Borrower covenants and agrees that Borrower's obligations and liability shall be joint and several. However, any Borrower who co-signs this Security Instrument but does not execute the Note (a "co-signer"): (a) is co-signing this Security Instrument only to mortgage, grant and convey the co-signer's interest in the Property under the terms of this Security Instrument; (b) is not personally obligated to pay the sums secured by this Security Instrument; and (c) agrees that Lender and any other Borrower can agree to extend, modify, forbear or make any accommodations with regard to the terms of this Security Instrument or the Note without the co-signer's consent.

Subject to the provisions of Section 18, any Successor in Interest of Borrower who assumes Borrower's obligations under this Security Instrument in writing, and is approved by Lender, shall obtain all of Borrower's rights and benefits under this Security Instrument. Borrower shall not be released from Borrower's obligations and liability under this Security Instrument unless Lender agrees to such release in writing. The covenants and agreements of this Security Instrument shall bind (except as provided in Section 20) and benefit the successors and assigns of Lender.

14. Loan Charges. Lender may charge Borrower fees for services performed in connection with Borrower's default, for the purpose of protecting Lender's interest in the Property and rights under this Security Instrument, including, but not limited to, attorneys' fees, property inspection and valuation fees. In regard to any other fees, the absence of express authority in this Security Instrument to charge a specific fee to Borrower shall not be construed as a prohibition on the charging of such fee. Lender may not charge fees that are expressly prohibited by this Security Instrument or by Applicable Law.

If the Loan is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the Loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. Lender may choose to make this refund by reducing the principal owed under the Note or by making a direct payment to Borrower. If a refund reduces principal, the reduction will be treated as a partial prepayment without any prepayment charge (whether or not a prepayment charge is provided for under the Note). Borrower's acceptance of any such refund made by direct payment to Borrower will constitute a waiver of any right of action Borrower might have arising out of such overcharge.

15. Notices. All notices given by Borrower or Lender in connection with this Security Instrument must be in writing. Any notice to Borrower in connection with this Security Instrument shall be deemed to have been given to Borrower when mailed by first class mail or when actually delivered to Borrower's notice address if sent by other means. Notice to any one Borrower shall constitute notice to all Borrowers unless Applicable Law expressly requires otherwise. The notice address shall be the Property Address unless Borrower has designated a substitute notice address by notice to Lender. Borrower shall promptly notify Lender of Borrower's change of address. If Lender specifies a procedure for reporting Borrower's change of address, then Borrower shall only report a change of address through that specified procedure. There may be only one designated notice address under this Security Instrument at any one time. Any notice to Lender shall be given by delivering it or by mailing it by first class mail to Lender's address stated herein unless Lender has designated another address by notice to Borrower. Any notice in connection with this Security Instrument shall not be deemed to have been given to Lender until actually received by Lender. If any notice required by this Security Instrument is also required under Applicable Law, the Applicable Law requirement will satisfy the corresponding requirement under this Security Instrument.

16. Governing Law; Severability; Rules of Construction. This Security Instrument shall be governed by federal law and the law of the jurisdiction in which the Property is located. All rights and obligations contained in this Security Instrument are subject to any requirements and limitations of Applicable Law. Applicable Law might explicitly or implicitly allow the parties to agree by contract or it might be silent, but such silence shall not be construed as a prohibition against agreement by contract. In the event that any provision or clause of this Security Instrument or the Note conflicts with Applicable Law, such conflict shall not affect other provisions of this Security Instrument or the Note which can be given effect without the conflicting provision.

22. Acceleration; Remedies. Lender shall give notice to Borrower prior to acceleration following Borrower's breach of any covenant or agreement to Borrower prior to acceleration unless Applicable Law provides otherwise. The notice shall specify: (a) the action required under Section 18 unless Applicable Law provides otherwise. The notice shall state the date given to Borrower, by which the default must be cured; (c) a date, not less than 30 days from the date the notice is given to Borrower, by which the default must be cured; and (d) that failure to cure the default on or before the date specified in the notice, Lender at its option may further foreclose property of the Borrower to remitate after acceleration and sale of the property. The notice shall further specify Borrower's right to accelerate by judicial proceeding and to assert acceleration of the sums secured by this Security Instrument and sale of the property. In the foreclosure proceeding the non-existence of a default or any other defense of Borrower to assert acceleration of the date specified in the notice is given to Borrower, by which the default must be cured; and (d) that failure to cure the default on or before the date specified in the notice is given to Borrower, by which the default must be cured.

NON-UNIFORM COVENANTS. Borrower and Lender further covenant and agree as follows:

Borrower shall promptly give Lender written notice of (a) any investigation, claim, demand, lawsuit or other action by any government or regulatory agency or private party involving the Property and any Hazardous Substances caused by any government or regulatory agency or private party or removal of any Hazardous Substances in connection with the release of the Property (including, but not limited to, hazardous substances in consumer products).

Borrower shall promptly give Lender written notice of (b) any remedial action taken by any other party to the release of the Property of small quantities that are generally recognized to be appropriate to normal residential uses and to maintainance of the Property, due to the presence, use, or storage of a Hazardous Substance that adversely affects the value of the Property, or (c) which, due to the presence, use, or release of a Hazardous Substance, creates a condition that endangers health safety or welfare of the Property, or (d) any Environmental Contamination, or (e) which Borrows has actual knowledge, leaking, discharge, release or threat of release of any Hazardous Substance, and (f) any condition caused by the presence, use, or storage of any Hazardous Substance, including but not limited to, any spillage, leaking, discharge, release or threat of release of any Hazardous Substance, Condition, or (g) any Environmental Law of which Borrower has actual knowledge, the Property and any Hazardous Substances Substance of which Borrower has actual knowledge, or removal of any Hazardous Substances in connection with the release of the Property.

Borrower shall promptly give Lender written notice of (b) any investigation, claim, demand, lawsuit or other action by any government or regulatory agency or private party involving the Property and any Hazardous Substances caused by any government or regulatory agency or private party or removal of any Hazardous Substances in connection with the release of the Property (including, but not limited to, hazardous substances in consumer products).

21. Hazardous Substances. As used in this Section 21: (a) "Hazardous Substances" are those substances defined as toxic or hazardous substances, polutants, or wastes by Environmental Law and the following substances: asbestos, materials containing asbestos or asbestos products, and asbestos materials; (b) "Environmental Law" means federal laws and regulations affecting the Property, or (c) that is in violation of any Environmental Law, (b) which creates an Environmental Contamination asbestosis or mesothelioma, or (c) which Borrows has actual knowledge, leaking, discharge, release or threat of release of any Hazardous Substance, and (d) any removal action taken by any government or regulatory agency or private party or removal of any Hazardous Substances in connection with the release of the Property, or (e) which, due to the presence, use, or storage of a Hazardous Substance, creates a condition that endangers health safety or welfare of the Property, or (f) any condition caused by the presence, use, or storage of any Hazardous Substance, including but not limited to, any spillage, leaking, discharge, release or threat of release of any Hazardous Substance, Condition, or (g) any Environmental Law of which Borrower has actual knowledge, the Property and any Hazardous Substances in connection with the release of the Property.

Neither Borrower nor Lender may cause the release of any substance and opportunity to take corrective action pursuant to Section 20.

Section 18 shall be deemed to satisfy the notice and opportunity to take corrective action of the Borrower given to Lender to Section 22 and the notice of acceleration given to Borrower pursuant to Section 18 shall be deemed to be reasonable for purposes of this paragraph. The notice of acceleration and opportunity to take corrective action, if applicable Law provides a time period before certain action can be taken, shall be deemed to be reasonable for the other party hereto to a reasonable period after the giving of such notice to Section 15) of such alleged breach and afforded the other party (with such notice given in compliance with the requirements of such Borrower or Lender has noticed the other party (with such notice given in compliance with the requirements of such Borrower or Lender has breached any provision of, or any duty owed by reason of, this Security Instrument, until all legal expenses that the other party has incurred prior to the notice of acceleration of this Security Instrument, until the Borrower or Lender may cause the release of any substance and opportunity to take corrective action of the Borrower given to Lender to Section 20.
