AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, on the 10th day of April, 1999, Dale G. McCullough and Elizabeth P. McCullough, Husband and Wife executed to UNION STATE BANK, WINTERSET, IOWA a certain note dated on that day for the sum of Fifty-one Thousand Two Hundred and no/100-----(\$51,200.00) DOLLARS, payable on the 10th day of April A.D., 2002, and at the same time the said Dale G. and Elizabeth P. McCullough executed to the said UNION STATE BANK a mortgage bearing even date with the said note, upon real estate described in said mortgage as security for payment of said note, which mortgage was recorded in the office of the Recorder of Madison County, Iowa, on the 12th day of April A.D., 1999 at 11:20 o'clock A. M., in Book 207 of Mortgages, on page 672 and,

Whereas, Dale G. and Elizabeth P. McCullough is now the owner of the real estate described in said Mortgage (XX

XX DOLLARS, and,

Whereas, there remains unpaid on the principal of said mortgage the sum of Forty-seven Thousand Three Hundred Sixty-one and 62/100-----(\$47,361.62) DOLLARS, and,

Whereas, the said makers have agreed with the holder of said mortgage to extend the time of payment thereon, NOW THEREFORE, the said Dale G. and Elizabeth P. McCullough hereby agrees to pay on the 15th day of April A.D., 2002, the principal sum of Forty-seven Thousand Three Hundred Sixty-one and 62/100-----(\$47,361.62) DOLLARS, remaining unpaid on the said note and mortgage, \$414.16 due monthly beginning on June 10, 2002 and each month thereafter until May 10, 2002 when unpaid balance is due with interest from April 10, 2002 at the rate of 7.5 per cent per annum due on monthly beginning on the 10th day of June, 2002 and each year thereafter, with both principal and interest payable at UNION STATE BANK, WINTERSET, IOWA; and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest as here in before stated from April 10, 2002 until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of _____ per cent per annum.
