Whereas, on the <u>24th</u> day of <u>May. 1996. Rebecca S. Newman, A Single Person</u> executed to <u>UNION STATE</u> <u>BANK, WINTERSET, IOWA</u> a certain note dated on that day for the sum of <u>Thirty-five Thousand and no/100------</u> <u>(35,000.00)</u> DOLLARS, payable on the <u>5th</u> day of <u>July</u>, A.D., <u>1996</u>, and at the same time the said <u>Rebecca S. Newman</u> executed to the said <u>UNION STATE BANK</u> a mortgage bearing even date with the said note, upon real estate described in said mortgage as security for payment of said note, which mortgage was recorded in the office of the Recorder of <u>Madison</u> County, Iowa, on the <u>24th</u> day of <u>May</u> A.D., <u>1996</u>, at <u>3:13</u> o'clock <u>P</u> M., in Book <u>182</u> of Mortgages, on page <u>271</u> and,

Whereas, Rebecca S. Newman Harkleroad now the owner of the real estate described in said mortgage and,

Whereas, the said makers have agreed with the holder of said mortgage to extend the time of payment thereon,

NOW THEREFORE, the said Rebecca S. Newman Harkleroad hereby agrees to pay on the 5th day of June

A.D., 20<u>02</u>, the principal sum of <u>Twenty-nine Thousand Five Hundred Sixty-nine and 78/100------</u>

(\$29,569.78) DOLLARS, remaining unpaid on the said note and mortgage, \$410.27 is to be paid monthly beginning

July 5, 2002 and each month thereafter until June 5, 2005 when the unpaid balance is due, with interest from June 3, 2002 at the rate of 7.5 per cent per annum payable monthly beginning on the 5th day of July, 2002 and each month thereafter, with both principal and interest payable at UNION STATE BANK, WINTERSET, IOWA: and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest as here in before stated from June 3, 2002 until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of ______ per cent per annum.
