4. **SECURED DEBT DEFINED.** The term "Secured Debt" includes, but is not limited to, the following:

Mortgagee at any one time shall not exceed the amount stated above. This limitation of amount does not include interest, loan charges, brokerage commissions, attorney fees and other charges validly made pursuant to this Mortgage and does not apply to advances (or interest accrued on such advances) made under the terms of this Mortgage to protect Lender's security and to perform any of the covenants contained in this Mortgage. Future advances are contemplated and, along with other future obligations, are secured by this Mortgage even though all or part may not yet be advanced. Nothing in this Mortgage is specifically referred to in the evidence of debt or note or whether or not this Mortgage is secured by Lender's security and to perform any of the covenants contained in this Mortgage even though all or part may not yet be advanced. Any such commitment would need to be agreed to in a separate writing.

B. All future advances from Lender to Mortagor or other future obligations of Mortagor to Lender under any promissory note, contract, guaranty, or other evidence of debt executed after this Mortgage is secured by Lender and does not limit the liability of Lender to Mortagor to the extent not prohibited by law, including, but not limited to, liabilities for overdrafts relating to any deposit account agreed to by law, which now exist or may later arise, to the extent not prohibited by law, whether or not this Mortgage is specifically referred to in the evidence of debt and whether or not such future advances or obligations are incurred for any purpose that was related or unrelated to the purpose of the Evidence of Debt.

3. **MAXIMUM OBLIGATION LIMIT.** The total principal amount of the Secured Debt (hereafter defined) secured by this

If Mortgagor is an entity other than a natural person (such as a corporation or other organization), Lender may demand immediate payment if (1) a beneficial interest in Mortgagor is sold or transferred; (2) there is a change in either the identity or number of members of a partnership or similar entity; or (3) there is a change in ownership of more than 25 percent of the voting stock of a corporation or similar entity. However, Lender may not demand payment in the above situations if it is prohibited by law as of the date of this Mortgage.

11. ENTITY WARRANTIES AND REPRESENTATIONS. If Mortgagor is an entity other than a natural person (such as a corporation or other organization), Mortgagor makes to Lender the following warranties and representations which shall be continuing as long as the Secured Debt remains outstanding:

- A. Mortgagor is an entity which is duly organized and validly existing in the Mortgagor's state of incorporation (or organization). Mortgagor is in good standing in all states in which Mortgagor transacts business. Mortgagor has the power and authority to own the Property and to carry on its business as now being conducted and, as applicable, is qualified to do so in each state in which Mortgagor operates.
- B. The execution, delivery and performance of this Mortgage by Mortgagor and the obligation evidenced by the Evidence of Debt are within the power of Mortgagor, have been duly authorized, have received all necessary governmental approval, and will not violate any provision of law, or order of court or governmental agency.
- C. Other than disclosed in writing Mortgagor has not changed its name within the last ten years and has not used any other trade or fictitious name. Without Lender's prior written consent, Mortgagor does not and will not use any other name and will preserve its existing name, trade names and franchises until the Secured Debt is satisfied.

12. PROPERTY CONDITION, ALTERATIONS AND INSPECTION. Mortgagor will keep the Property in good condition and make all repairs that are reasonably necessary. Mortgagor will give Lender prompt notice of any loss or damage to the Property. Mortgagor will keep the Property free of noxious weeds and grasses. Mortgagor will not initiate, join in or consent to any change in any private restrictive covenant, zoning ordinance or other public or private restriction limiting or defining the uses which may be made of the Property or any part of the Property, without Lender's prior written consent. Mortgagor will notify Lender of all demands, proceedings, claims, and actions against Mortgagor or any other owner made under law or regulation regarding use, ownership and occupancy of the Property. Mortgagor will comply with all legal requirements and restrictions, whether public or private, with respect to the use of the Property. Mortgagor also agrees that the nature of the occupancy and use will not change without Lender's prior written consent.

No portion of the Property will be removed, demolished or materially altered without Lender's prior written consent except that Mortgagor has the right to remove items of personal property comprising a part of the Property that become worn or obsolete, provided that such personal property is replaced with other personal property at least equal in value to the replaced personal property, free from any title retention device, security agreement or other encumbrance. Such replacement of personal property will be deemed subject to the security interest created by this Mortgage. Mortgagor shall not partition or subdivide the Property without Lender's prior written consent. Lender or Lender's agents may, at Lender's option, enter the Property at any reasonable time for the purpose of inspecting the Property. Any inspection of the Property shall be entirely for Lender's benefit and Mortgagor will in no way rely on Lender's inspection.

13. AUTHORITY TO PERFORM. If Mortgagor fails to perform any of Mortgagor's duties under this Mortgage, or any other mortgage, deed of trust, security agreement or other lien document that has priority over this Mortgage, Lender may, without notice, perform the duties or cause them to be performed. Mortgagor appoints Lender as attorney in fact to sign Mortgagor's name or pay any amount necessary for performance. If any construction on the Property is discontinued or not carried on in a reasonable manner, Lender may do whatever is necessary to protect Lender's security interest in the Property. This may include completing the construction.

Lender's right to perform for Mortgagor shall not create an obligation to perform, and Lender's failure to perform will not preclude Lender from exercising any of Lender's other rights under the law or this Mortgage. Any amounts paid by Lender for insuring, preserving or otherwise protecting the Property and Lender's security interest will be due on demand and will bear interest from the date of the payment until paid in full at the interest rate in effect from time to time according to the terms of the Evidence of Debt.

14. CONDOMINIUMS; PLANNED UNIT DEVELOPMENTS. If the Property includes a unit in a condominium or a planned unit development, Mortgagor will perform all of Mortgagor's duties under the covenants, by-laws, or regulations of the condominium or planned unit development.

15. DEFAULT. Mortgagor will be in default if any of the following occur:

- A. Any party obligated on the Secured Debt fails to make payment when due;
- B. A breach of any term or covenant in this Mortgage, any prior mortgage or any construction loan agreement, security agreement or any other document evidencing, guarantying, securing or otherwise relating to the Secured Debt;

- D. Mortagagor has no knowledge of or reason to believe there is any pending or threatened investigation, claim, or proceeding, in such an event, Lender has the right, but not the obligation to participate in any such proceeding or writing as soon as Mortagagor has reason to believe there is any such pending or threatened investigation, claim, or proceeding of any kind relating to (1) any Hazardous Substance located on, under or about the Property; or (2) any violation by Mortagagor or any tenant of any Environmental Law. Mortagagor will immediately notify Lender in writing of any kind relating to (1) any Hazardous Substance located on, under or about the Property; or (2) any violation by Mortagagor or any tenant of any Environmental Law.
- C. Mortagagor will immediately notify Lender if (1) a release or threatened release of any Hazardous Substance occurs on, under or about the Property or migates to migrate nearby property, or (2) there is a violation of any Environmental Law concerning the Property, except in the ordinary course of business and in strict compliance with all applicable Environmental Law.
- B. Mortagagor has not and will not cause, contribute to, or permit the release of any Hazardous Substance on the property that all person on, under or about the Property, except in the ordinary course of business and in strict compliance with all applicable Environmental Law.
- A. No Hazardous Substance has been, is, or will be located, transported, manufactured, refined, treated, refined, or handled by any person, under or about the Property, except in the ordinary course of business and in strict compliance with all applicable Environmental Law.

Mortagagor agrees to pay all costs and expenses incurred by Lender in enforcing or protecting the Property, defending in respect to the Property, or in any suit or action brought against Lender under any section of this Agreement, or in any suit or action brought against Lender for any damages sustained by Lender due to the agreement of the parties to pay all fees and charges, accrued interest and principal shall become immediately due and payable, after giving notice if required by law, upon the occurrence of a default or anytime thereafter. In addition, Lender shall be entitled to all the remedies provided by law, the Evidence of Debt, other evidences of debt, this Mortgage and any related documents. All remedies set forth or not. The acceptance by Lender is entitled to all remedies provided at law or equity, whether expressly set forth or not. Mortagagor agrees that in the event of foreclosure of this Mortgage, at the sole discretion of Lender, Lender may elect to extend the period of redemption for the sale of the Property to a period of time as may then be authorized under the circumstances and under any section of Iowa Code Chapter 628, or any other Iowa Code section, now in effect or as may be in effect at the time of foreclosure.

- At the option of Lender, all or any part of the agreed fees and charges, accrued interest and principal shall become immediately due and payable, after giving notice if required by law, upon the occurrence of a default or anytime thereafter. In addition, Lender shall be entitled to all the remedies provided by law, the Evidence of Debt, other evidences of debt, this Mortgage and any related documents. All remedies set forth or not. The acceptance by Lender is entitled to all remedies provided at law or equity, whether expressly set forth or not. 16. REMEDIES ON DEFAULT. In some instances, federal and state law will require Lender to provide Mortagagor with notice of the right to cure, mediation notices or other notices and may establish time schedules for foreclosure actions. Subject to these limitations, if any, Lender may accelerate the Secured Debt and foreclose this Mortgage in a manner provided by law if this Mortgage is in default.
- G. Any loan proceeds are used for a purpose that will contribute to excessive erosion of highly erodible land or to the conversion of wetlands to produce an agricultural commodity, as further explained in 7 C.F.R. Part 1940, Subpart G, Exhibit M.
- F. A material adverse change in Mortagagor's business including ownership, management, and financial conditions, which Lender in its opinion believes impairs the value of the Property or repayment of the Secured Debt; or
- E. A good faith belief by Lender at any time that lender is impeded or the value of the Property is impaired; the Secured Debt or that the prospect of any payment is impeded or any person with respect to any entity obligated on the Secured Debt;
- D. The death, dissolution, or insolvency of Mortagagor or any person or entity obligated on the Secured Debt;
- C. The making of furnishing of any verbal or written representation, statement or warranty to Lender that is false or incorrect in any material respect by Mortagagor or any person or entity obligated on the Secured Debt;
- B. Mortagagor or any person or entity obligated on the Secured Debt;
- A. Good faith belief by Lender at any time that lender is impeded or the value of the Property is impaired; the Secured Debt or that the prospect of any payment is impeded or any person with respect to any entity obligated on the Secured Debt;
- G. Any loan proceeds are used for a purpose that will contribute to excessive erosion of highly erodible land or to the conversion of wetlands to produce an agricultural commodity, as further explained in 7 C.F.R. Part 1940, Subpart G, Exhibit M.
- H. Mortagagor in its opinion believes impairs the value of the Property or repayment of the Secured Debt; or
- I. Mortagagor has not timely paid any taxes, insurance premiums, or other amounts due to the State or any political subdivision.
- J. Mortagagor has sold or transferred any interest in the Property or has otherwise disposed of the Property in a manner that Lender does not approve.
- K. Mortagagor has breached any covenant contained in this Agreement.
- L. Mortagagor has committed any act or omission which Lender believes is likely to result in a violation of any applicable law, regulation, or rule.
- M. Mortagagor has failed to pay any amount due under this Agreement or has failed to perform any other obligation under this Agreement.
- N. Mortagagor has filed for relief under the bankruptcy laws or any similar laws.
- O. Mortagagor has filed for protection under the Bankruptcy Act or any other bankruptcy or similar law.
- P. Mortagagor has engaged in any conduct which Lender believes is likely to result in a violation of any applicable law, regulation, or rule.
- Q. Mortagagor has violated any provision of this Agreement.
- R. Mortagagor has committed any act or omission which Lender believes is likely to result in a violation of any applicable law, regulation, or rule.
- S. Mortagagor has engaged in any conduct which Lender believes is likely to result in a violation of any applicable law, regulation, or rule.
- T. Mortagagor has filed for protection under the Bankruptcy Act or any other bankruptcy or similar law.
- U. Mortagagor has engaged in any conduct which Lender believes is likely to result in a violation of any applicable law, regulation, or rule.
- V. Mortagagor has violated any provision of this Agreement.
- W. Mortagagor has engaged in any conduct which Lender believes is likely to result in a violation of any applicable law, regulation, or rule.
- X. Mortagagor has filed for protection under the Bankruptcy Act or any other bankruptcy or similar law.
- Y. Mortagagor has engaged in any conduct which Lender believes is likely to result in a violation of any applicable law, regulation, or rule.
- Z. Mortagagor has violated any provision of this Agreement.

- E. Mortgagor and every tenant have been, are and shall remain in full compliance with any applicable Environmental Law.
- F. There are no underground storage tanks, private dumps or open wells located on or under the Property and no such tank, dump or well will be added unless Lender first consents in writing.
- G. Mortgagor will regularly inspect the Property, monitor the activities and operations on the Property, and confirm that all permits, licenses or approvals required by any applicable Environmental Law are obtained and complied with.
- H. Mortgagor will permit, or cause any tenant to permit, Lender or Lender's agent to enter and inspect the Property and review all records at any reasonable time to determine (1) the existence, location and nature of any Hazardous Substance on, under or about the Property; (2) the existence, location, nature, and magnitude of any Hazardous Substance that has been released on, under or about the Property; or (3) whether or not Mortgagor and any tenant are in compliance with applicable Environmental Law.
- I. Upon Lender's request and at any time, Mortgagor agrees, at Mortgagor's expense, to engage a qualified environmental engineer to prepare an environmental audit of the Property and to submit the results of such audit to Lender. The choice of the environmental engineer who will perform such audit is subject to Lender's approval.
- J. Lender has the right, but not the obligation, to perform any of Mortgagor's obligations under this section at Mortgagor's expense.
- K. As a consequence of any breach of any representation, warranty or promise made in this section, (1) Mortgagor will indemnify and hold Lender and Lender's successors or assigns harmless from and against all losses, claims, demands, liabilities, damages, cleanup, response and remediation costs, penalties and expenses, including without limitation all costs of litigation and attorneys' fees, which Lender and Lender's successors or assigns may sustain; and (2) at Lender's discretion, Lender may release this Mortgage and in return Mortgagor will provide Lender with collateral of at least equal value to the Property secured by this Mortgage without prejudice to any of Lender's rights under this Mortgage.
- L. Notwithstanding any of the language contained in this Mortgage to the contrary, the terms of this section shall survive any foreclosure or satisfaction of this Mortgage regardless of any passage of title to Lender or any disposition by Lender of any or all of the Property. Any claims and defenses to the contrary are hereby waived.

20. CONDEMNATION. Mortgagor will give Lender prompt notice of any action, real or threatened, by private or public entities to purchase or take any or all of the Property, including any easements, through condemnation, eminent domain, or any other means. Mortgagor further agrees to notify Lender of any proceedings instituted for the establishment of any sewer, water, conservation, ditch, drainage, or other district relating to or binding upon the Property or any part of it. Mortgagor authorizes Lender to intervene in Mortgagor's name in any of the above described actions or claims and to collect and receive all sums resulting from the action or claim. Mortgagor assigns to Lender the proceeds of any award or claim for damages connected with a condemnation or other taking of all or any part of the Property. Such proceeds shall be considered payments and will be applied as provided in this Mortgage. This assignment of proceeds is subject to the terms of any prior mortgage, deed of trust, security agreement or other lien document.

21. INSURANCE. Mortgagor agrees to maintain insurance as follows:

- A. Mortgagor shall keep the improvements now existing or hereafter built on the Property insured against loss by fire, hazards included within the term "extended coverage" and any other hazards, including floods or flooding, for which Lender requires insurance. This insurance shall be maintained in the amounts and for the periods that Lender requires. The insurance carrier providing the insurance shall be chosen by Mortgagor subject to Lender's approval, which shall not be unreasonably withheld. If Mortgagor fails to maintain the coverage described above, Lender may, at Lender's option, obtain coverage to protect Lender's rights in the Property according to the terms of this Mortgage.

All insurance policies and renewals shall be acceptable to Lender and shall include a standard "mortgage clause" and, where applicable, "lender loss payee clause." Mortgagor shall immediately notify Lender of cancellation or termination of the insurance. Lender shall have the right to hold the policies and renewals. If Lender requires, Mortgagor shall immediately give to Lender all receipts of paid premiums and renewal notices. Upon loss, Mortgagor shall give immediate notice to the insurance carrier and Lender. Lender may make proof of loss if not made immediately by Mortgagor.

Unless Lender and Mortgagor otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged if the restoration or repair is economically feasible and Lender's security is not lessened. If the restoration or repair is not economically feasible or Lender's security would be lessened, the insurance proceeds shall be applied to the Secured Debt, whether or not then due, with any excess paid to Mortgagor. If Mortgagor abandons the Property, or does not answer within 30 days a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may collect the insurance proceeds. Lender may use the proceeds to repair or restore the Property or to pay the Secured Debt whether or not then due. The 30-day period will begin when the notice is given.

Unless Lender and Mortgagor otherwise agree in writing, any application of proceeds to principal shall not extend or postpone the due date of scheduled payments or change the amount of the payments. Time is of the essence in this agreement.

24. JOINT AND INDIVIDUAL LIABILITY; CO-SIGNERS; SUCCESSORS AND ASSIGNS BOUND. All duties under this Mortgage are joint and individual. If Mortagor signs this Mortgage but does not sign the Evidence of Debt, Mortagor does so only to be personally liable on the Property to secure payment of the Secured Debt and Mortagor does not agree to modify or make any change in the terms of this Mortgage. 


