Addendum

1. All right, title and interest in and to: SEE EXHIBIT "A" ATTACHED HERETO.

Subject to a Real Estate Contract to sell said real estate to Daniel W. Strable and Regina Strable, husband and wife, Lee R. Hill and Pam Hill, husband and wife, and Lance Vrana, single, which Contract is recorded in Book 131, Page 5 of the Recorder's office of Madison County, Iowa. All of the right, title and interest of the Marlene Fettkether Estate in and to said Contract, is hereby assigned to Gary G. Shearer.

This Deed is given for the purpose of making distribution in the above estate. Therefore, no Declaration of Value or Groundwater Statement is required.

The North Half (N1) of the Southwest Fractional Quarter (SW Fr 1) and the Southeast Quarter (SE1), and all of the South Half (S1) of the Northwest Fractional Quarter (NW Fr 1) lying South of a line described as follows: Commencing at the Southeast (SE) corner of the North Half (N1) of the Northwest Fractional Quarter (NW Fr 1), thence South 00°17′59" East, 201.47 feet to the centerline of the County road, and the Point of Beginning of said line; thence along said centerline, South 79°29′34" West, 235.54 feet; thence Westerly 296.70 feet along a 571.20 foot radius curve, concave Northerly, having a central angle of 29°45′42" and a long chord bearing North 85°37′35" West, 293.38 feet; thence departing said centerline, South 40°48′47" West, 89.62 feet; thence South 14°30′54" West, 86.51 feet; thence South 65°35′21" West, 447.80 feet; thence South 69°26′05" West, 81.45 feet to the Westline of said Northwest Fractional Quarter (NW Fr 1), all in Section Six (6), Township Seventy-four (74) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa,
