AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, on the 20th day of December, 1999, 1998, Thomas Duane Allen and Anita Allen, Husband and Wife executed to UNION STATE BANK, WINTERSET, IOWA a certain note dated on that day for the sum of Sixty-seven Thousand Five Hundred and no/100----- (67,500.00) DOLLARS, payable on the 30<sup>th</sup> day of December, A.D., 2002, and at the same time the said Thomas Duane Allen and Anita Allen executed to the said UNION STATE BANK a mortgage bearing even date with the said note, upon real estate described in said mortgage as security for payment of said note, which mortgage was recorded in the office of the Recorder of Madison County, Iowa, on the 27th day of December A.D., 1999, at 9:48 o'clock P M., in Book 214 of Mortgages, on page 336 and,

Whereas, Thomas D. Allen is now the owner of the real estate described in said mortgage and,

Whereas, there remains unpaid on the principal of said mortgage the sum of Sixty-four Thousand Six Hundred Eighty-four and 82/100----- (\$ 64,684.82) DOLLARS, and,

Whereas, the said makers have agreed with the holder of said mortgage to extend the time of payment thereon,

NOW THEREFORE, the said Thomas D. Allen hereby agrees to pay on the 26<sup>th</sup> day of November A.D., 02, the principal sum of Sixty-four Thousand Six Hundred Eighty-four and 82/100----- (\$64,684.82) DOLLARS, remaining unpaid on the said note and mortgage, monthly interest payments are be paid monthly beginning January 2, 2003 and each month thereafter until April 2, 2003 when the unpaid balance is due, with interest from November 26, 2002 at the rate of 8.4 per cent per annum payable monthly beginning on the 2nd day of January, 2003 and each month thereafter, with both principal and interest payable at UNION STATE BANK, WINTERSET, IOWA; and the said makers hereby covenant and warrant that said mortgage is a lien on the land therein described and that it shall continue and remain as security for the payment of said principal remaining unpaid on said mortgage, and the interest as here in before stated from November 26, 2002 until paid, and in case of failure to comply with any one of the conditions hereof, or any of the conditions of the said mortgage, all of the provisions of said mortgage becoming a part of this instrument, then the whole debt shall become due and collectible at the option of the owner of said mortgage; and all the covenants and condition of said mortgage shall remain in force except as modified by this instrument; and all sums of money not paid when due as provided in this contract shall bear interest at the rate of \_\_\_\_\_ per cent per annum.
