### SATISFACTION OF MORTGAGE



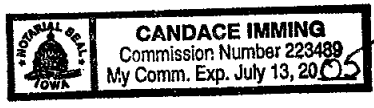


