QUIT CLAIM DEED

Commencing at a point 33 feet West and 144 feet North of the Southeast Corner of the Northeast Quarter (½) of the Northeast Quarter (½) in Section Thirty-six (36), Township Seventy-six (76) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, thence West 264 feet, thence North 132 feet, thence East 10 feet, thence North 205 feet, thence East 254 feet, thence South 337 feet to the point of beginning, except Parcel "A" located in the East Half (½) of the Northeast Quarter (¼) of Section Thirty-six (36), Township Seventy-six (76) North, Range Twenty-eight (28) West of the 5th P.M., City of Winterset, containing 0.582 acres, as shown in Plat of Survey filed in Book 2, Page 301 on October 24, 1996, in the Office of the Recorder of Madison County, Iowa.
