BE IT REMEMBERED that at a special meeting of the ISU Community Credit Union, a Corporation existing under Chapter 533, ~~XX~~ Code of Iowa and amendments thereto, held at Ames, Iowa, on the 28th day of October 2002, by motion duly made and carried, Item (1) of the Articles of Incorporation was amended, subject to the approval of the Credit Union Division, so that the same shall read as follows:

- 1) The name of this Credit Union shall be **Greater Iowa Credit Union** effective 28th day of October, 2002 and the principal office of the Credit Union shall be Ames, Iowa.

BE IT FURTHER REMEMBERED that the Chairperson and Secretary of the Board of Directors are authorized to sign, acknowledge and record and do all things required by law to carry the above amendment into effect.

We, Aaron Davenport, Chairperson, and Larry Courture, Secretary of said Corporation, do hereby certify the above to be a true and correct statement of the proceedings at the above named meeting pertaining to the proposed amendment to the Articles of Incorporation, as applicable, of said Corporation.

WE FURTHER STATE that, as provided by the bylaws of said Corporation and the laws of the State of Iowa, said meeting was held in accordance with due and regular notice hereof given to all members of said Corporation, that a quorum was present at this meeting and that the amendment herein before set out did accompany said notice.

NOW, THEREFORE, in conformity with the above mentioned authority, we Aaron Davenport, Chairperson, and Larry Courture, Secretary of the ISU Community Credit Union, have executed this instrument and do hereby acknowledge same for and on behalf of said Corporation this 9th day of December, 2002.

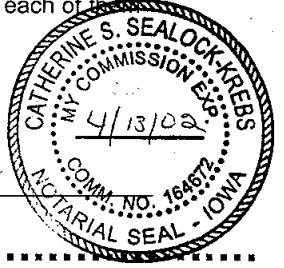
