Addendum

1. The South Eleven (11) acres of the Northwest Fractional Quarter (¼) of the Southwest Quarter (¼) of Section Eighteen (18), Township Seventy-five (75) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, excepting therefrom the following described tracts: 1. Commencing at the Southeast Corner of the South Eleven (11) acres of the Northwest Fractional Quarter (¼) of the Southwest Quarter (¼) of Section Eighteen (18) in Township Seventy-five (75) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, thence North 150 feet, thence West 300 feet, thence South 150 feet, thence East 300 feet to the place of beginning; and 2. Commencing at the Northeast Corner of the South Eleven (11) acres of the Northwest Fractional Quarter (¼) of the Southwest Quarter (¼) of Section Eighteen (18), Township Seventy-five (75) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa, thence West 444 feet, thence South 190 feet, thence Southeasterly to a point 340 feet West of the East line of said Eleven (11) acre tract, thence East 340 feet, thence North 210 feet to the place of beginning "(It is assumed that the East boundary of said Eleven (11) acre tract is 40 feet East of the right-of-way line of the now existing highway)."

A parcel of land described as commencing at the Northwest Corner of the Southwest Quarter (1/4) of the Southwest Fractional Quarter (1/4) of Section Eighteen (18), Township Seventy-five (75) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa; thence North 89°01'49" East 1488.14 feet along the North line of said Southwest Quarter (1/4) of the Southwest Fractional Quarter (1/4) to the centerline of a County Road (old Highway #169); thence South 00°16'58" East 44.90 feet; thence South 88°13'06" West 695.68 feet; thence North 42°43'45" West 66.40 feet; thence South 89°25'49" West 747.80 feet to the Point of Beginning containing 0.8712 acres.
