- 1. On April 15, 2002, the City Council adopted Resolution No. 2002-30 a Resolution Setting Date for a Public Hearing on Zoning Regulations and Subdivision Regulations, a copy of which is attached hereto.
- 2. On May 8, 2002, notice of public hearing was published in the Winterset Madisonian, a copy of the Affidavit of Publication is attached hereto.
- 3. On May 20, 2002, the City Council conducted a public hearing on the proposed revisions to the Zoning and Subdivision regulations.
- 4. 
