RELEASE OF PIPELINE EASEMENT

THAT, WHEREAS, on May 17, 1961, C.L. Stanley and Gladys Stanley, granted and conveyed a Pipeline Easement (recorded in Book 90 on Page 344 on May 24, 1961 in the Deed Records of Madison County, Iowa) to Northern Gas Products Company, a right-of-way to construct, operate, inspect, maintain, replace, and remove a pipeline and appurtenances thereto, for the transportation of liquid or gaseous substances of any sort through the following described lands in Madison County, Iowa, to-wit:

W 1/2 of NW 1/4 and SE 1/4 of NW 1/4 (147.03 acres) of Section 12,
Township 77 North, Range 26 West, of Madison County, Iowa

(the above described real estate being hereinafter referred to as "said Real Estate" and the above mentioned Pipeline Easement being hereinafter referred to as "said Agreement," and

WHEREAS, Kinder Morgan Operating, L.P. "A", a Delaware limited partnership, (hereinafter referred to as "Kinder Morgan") is the present owner of certain rights, title and interest in and to the aforesaid Pipeline Easement; and said Agreement, and

WHEREAS, "Kinder Morgan" wishes to release all of its right, title and interest in and to said Real Estate as acquired by virtue of said Agreement.

NOW, THEREFORE, "Kinder Morgan" does hereby release, quitclaim and convey unto the present record owners, their heirs, successors and assigns, all of Kinder Morgan's right, title and interest in and to said Real Estate as acquired by virtue of said Agreement located in Madison County, Iowa.

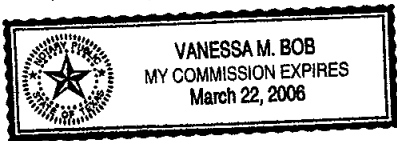
