PARTIAL RELEASE OF SOIL EROSION CONTROL MAINTENANCE AGREEMENT

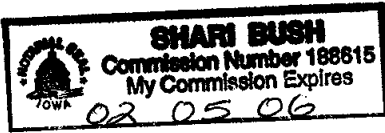
