


WHEREAS, Iowa Code Section 364.7 requires public notice be made on the proposal.



WHEREAS, the public hearing has been held and all interested persons have been heard on the proposal,


WHEREAS, the City Council now determines that the conveyance of the real estate above described should be approved in all respects as proposed.
