

The West Fractional Half (1/2) of the Northwest Quarter (1/4) of Section Six (6), Township Seventy-five (75) North of Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, except .1 acre for road purposes; AND Commencing at the Northeast Corner of the Northeast Quarter (1/4) of Section One (1), and running South to the Southeast corner, thence West along the South side of the Northeast Quarter (1/4) 845 feet, more or less, to County Road running North and South, thence North along the East line of said Road to North line of said quarter Section, thence East to place of beginning, EXCEPT Commencing at the Northeast Corner of the Northeast Quarter (1/4) of Section One (1), thence West along the North line of said quarter Section to the East line of the County Road running North and South which is the point of beginning; thence commencing South 146 feet, thence East 141 feet, thence South 223 feet, thence East 211 feet, thence North 369 feet, more or less, to the North line of said quarter Section, thence West along the North line of said quarter Section 352 feet, more or less, to the point of beginning; all in Township Seventy-five (75) North of Range Twenty-nine (29) West of the 5th P.M., Madison County, Iowa.
