REAL ESTATE CONTRACT MODIFICATION AGREEMENT

This Real Estate Contract Modification Agreement is entered into on this 26th day of August, 2003, by and between Raccoon Valley State Bank, an Iowa Corporation of the County of Dallas, State of Iowa, ("Sellers"): and Howard K. Clayton, Sr. and Betty L. Clayton of the County of Dallas, State of Iowa, ("Buyers");

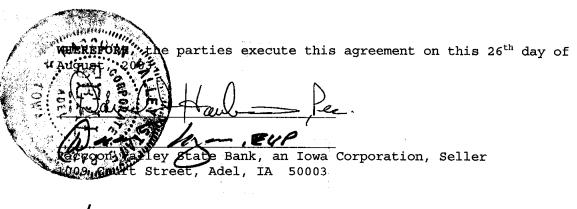
RECITAL

A. Sellers and Buyers entered into a certain REAL ESTATE CONTRACT-INSTALLMENTS dated the 24th day of August, 2000 and recorded in file no. 005685, Book 142, Page 883 AND a certain REAL ESTATE CONTRACT MODIFICATION AGREEMENT dated 19th day of October, 2001 and recorded in file no. 004806, Book 2001, Page 4806 at the Madison County Recorder, Winterset, Iowa and now desire to modify certain terms.

COVENANTS

NOW, THEREFORE, in consideration of one dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- INTEREST RATE Interest (7.25% per annum, previously) shall be calculated at the rate of 6.25% per annum beginning on the above date.
- 2. PAYMENT AMOUNT The monthly payment amount shall be reduced from \$664.38 due each month on or before the 25th to \$590.82 on or before September 25, 2003, and \$590.82 on or before the 25th day of each and every month thereafter including interest on unpaid balance thereof at the rate of 6.25% per annum, payable monthly through and including August 25, 2006 with the entire unpaid principal and interest balance due on August 25, 2006. Payments shall be applied first to interest then unpaid and the rest upon the balance of the principal.
- 3. Except as expressly modified herein, all other terms shall remain in full force and effect.
