hereinafter referred to as GRANTORS, in consideration of One Dollar and Other Valuable Consideration, hereby grant and convey unto Warren Water, Inc., hereinafter referred to as GRANTEE, its successors and assigns, a perpetual easement with the right to erect, construct, install, lay and thereafter use, operate, inspect, repair, maintain, replace and remove waterlines and appurtenances thereto, over, across and through the land of the GRANTORS situated in Madison County, Iowa, being more specifically described as follows:

The Southwest Quarter (1/4) of Section Thirty-three (33), Township Seventy-seven (77) North, Range Twenty-nine (29) West of the 5th P.M., Madison County, Iowa, EXCEPT Parcel "A" located in the Southwest Quarter of the Southwest Quarter of Section 33, Township 77 North, Range 29 West of the 5th P.M., Madison County, Iowa, more particularly described as follows: Commencing at the South Quarter corner of Section 33, Township 77 North, Range 29 West of the 5th P.M., Madison County, Iowa; thence South 90° 00' 00" West, 1646.51 feet along the South line of the Southwest Quarter of said Section 33 to the Point of Beginning; thence South 90° 00' 00" West, 321.72 feet along the South line of the Southwest Quarter of said Section 33; thence North 0° 02' 15" East, 407.00 feet along the projection of an existing fenceline; thence North 90° 00' 00" East, 324.92 feet to a point in an existing fenceline; thence South 0° 29' 19" West, 407.01 feet along a projection of an existing fenceline to the Point of Beginning.
