## MIDAMERICAN ENERGY COMPANY AGREEMENT

This Agreement is filed as an Addendum to the Document captioned as **MidAmerican Energy Company Option For Electric Line Easement** filed for record in Book 2003, on Page 6052, Document No. 6052 of the Records of Madison County, Iowa on the 7th day of October 2003.

<u>Iowa Code</u> Section 478.20, Distance from Buildings, states:

No transmission line shall be constructed, except by agreement, within one hundred feet of any dwelling house or other building, except where said line crosses or passes along a public highway or is located alongside or parallel with the right of way of any railway company. In addition to the foregoing, each person, company, or corporation shall conform to any other rules, regulations, or specifications established by the utilities board, in the construction, operation, or maintenance of such lines.

The undersigned Owner(s), Jeffery A. Linn and Linda J. Linn, husband and wife, as joint tenants with full rights of survivorship and not as tenants in common, are the owner(s) of a Property legally described as:

A tract of land in the East Half (1/2) of the Southeast Quarter (1/4) of Section Twelve (12), in Township Seventy-Seven (77) North, Range Twenty-nine (29) West of the 5th P.M., Madison County, Iowa more particularly described as follows: Commencing at the Southeast corner of said Section Twelve (12), thence along the East line of the Southeast Quarter (1/4) of said section, North 00° 09' 28" East 935.81 feet to the point of beginning; thence North 86° 02' 43" West 342.68 feet; thence North 00° 33' 14" East 222.46 feet; thence North 87° 56' 39" West 9.76 feet; thence North 00° 23' 27" West 58.64 feet; thence North 00° 47' 09" East 530.02 feet; thence North 88° 55' 30" East 344.96 feet to the East line of said Southeast Quarter (1/4) (also being the centerline of County Highway P-57); thence along said East line, South 00° 09' 28" W. 841.52 feet to the point of beginning, containing 6.57 acres more or less, including county road right of way.
