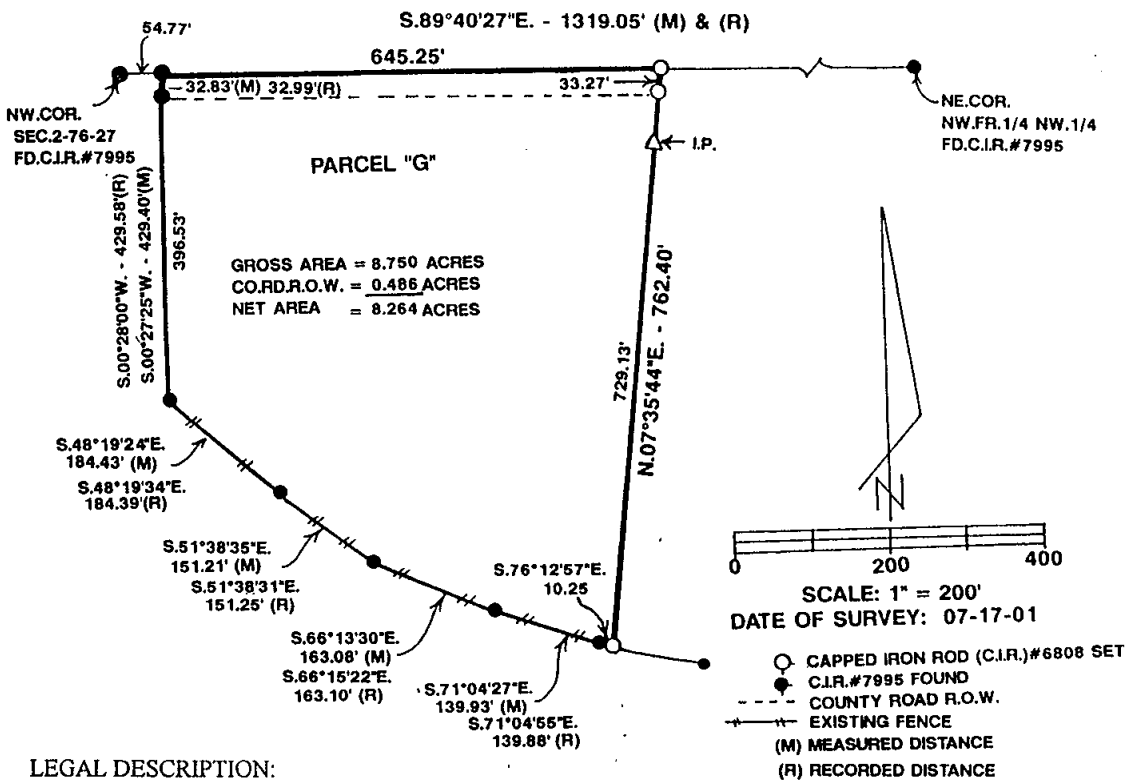

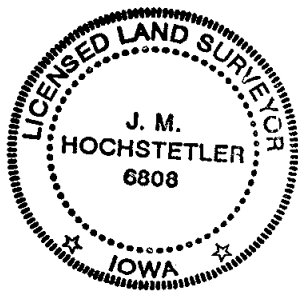


LEGAL DESCRIPTION:
