




O.S. - CREEK OFFSET MONUMENT

DESCRIPTION - PARCEL A

That part of the south half of the Southeast Quarter of Section 23, Township 76 North, Range 28 West of the Fifth Principal Meridian, Madison County, Iowa, described as follows:

Beginning at the northwest corner of the Southwest Quarter of the Southeast Quarter of said Section 23;

thence on an assumed bearing of North 89 degrees 57 minutes 57 seconds East along the north line of the south half of the Southeast Quarter of said Section 23 a distance of 584.51 feet;

thence South 02 degrees 05 minutes 35 seconds West 719.07 feet to the centerline of Cedar Creek:

thence North 81 degrees 40 minutes 45 seconds West along said centerline 196.74 feet; thence South 76 degrees 57 minutes 32 seconds West along said centerline 191.05 feet; thence North 88 degrees 08 minutes 14 seconds West along said centerline 185.17 feet to the west line of the Southwest Quarter of the Southeast Quarter of said Section 23; thence North 00 degrees 36 minutes 01 seconds East along said west line 726.90 feet to the northwest corner of said Southwest Quarter of the Southeast Quarter and the point of beginning.

Said tract contains 9.44 acres and is subject to a Madison County Highway Easement over the westerly 0.55 acres thereof.
