## ASSIGNMENT, ASSUMPTION AND RELEASE AGREEMENT

THIS ASSIGNMENT, ASSUMPTION AND RELEASE AGREEMENT (this "Agreement") is made and entered into this 16<sup>th</sup> day of December, 2003 and effective as of the 1<sup>st</sup> day of January 2004, by and among HEARTLAND RAIL CORPORATION, an Iowa corporation ("Assignor"), IOWA INTERSTATE RAILROAD, LTD., a Delaware corporation ("Assignee"), IOWA RAILWAY FINANCE AUTHORITY ("IRFA") and IOWA DEPARTMENT OF TRANSPORTATION ("IDOT," IRFA and IDOT together, the "Lenders").

## Recitals

WHEREAS, Assignor desires to assign, and Assignee desires to assume, the Assumed Obligations, as such term is defined below, in connection with the transfer from Assignor to Assignee of certain specified assets of Assignor; and

WHEREAS, in connection with the assignment by Assignor and the assumption by Assignee of the Assumed Obligations, Lenders have agreed to release Assignor from any and all obligations, liabilities or claims with respect to the Assumed Obligations.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties, each intending to be legally bound hereby, agree as follows:

- 1. Assignment. Assignor, effective as of January 1, 2004, assigns, conveys and transfers to Assignee all of the rights, title and interests of Assignor in and to those certain agreements and obligations listed and described on Exhibit "A" attached hereto (the "Assumed Obligations").
- 2. <u>Assumption</u>. Assignee hereby assumes and agrees to perform, discharge, observe and be liable for any and all duties, obligations and liabilities of Assignor with respect to the Assumed Obligations, and any and all claims, suits, proceedings, restrictions, limitations, security interests, liens or encumbrances against Assignor in respect of the Assumed Obligations, and Assignee agrees to indemnify and hold Assignor harmless from any and all claims, costs, loss and damage arising from or related to the Assumed Obligations or this Agreement.

- 3. Release. Lenders hereby consent to this Agreement and the assignment and assumption of the Assumed Obligations as set forth herein and unconditionally release and forever discharge Assignor from any and all obligations and liabilities related to the Assumed Obligations.
- 4. <u>Further Assurances</u>. At Assignee's request, Assignor shall do, execute, acknowledge and deliver or shall cause to be done, executed, acknowledged and delivered such further acts, transfers, conveyances, assignments and assurances as reasonably may be required to assure, convey and transfer the Assignor's right, title and interest in the Assumed Obligations. At Assignor's request, Assignee shall do, execute, acknowledge and deliver or shall cause to be done, executed, acknowledged and delivered such further acts, documents, and assurances as reasonably may be required to assure Assignor's release from any and all obligations, liabilities, claims, suits, proceedings, restrictions, limitations, security interests, liens or encumbrances related to the Assumed Obligations.


