

## AMENDMENT TO MORTGAGE

Parcel "B", a part of the Northeast Quarter (1/4) of Section 33, Township 75 North, Range 29 West of the 5<sup>th</sup> P.M., Madison County, Iowa, described as follows: Commencing at the Northeast Corner of said Section 33; thence S 00° 23' 13" W a distance of 462.89 feet to the Point of Beginning; thence S 00° 23' 13" W a distance of 845.66 feet; thence S 83° 22' 01" W a distance of 797.80 feet; thence N 00° 28' 19" W a distance of 740.11 feet; thence N 59° 36' 14" E a distance of 172.67 feet; thence N 03° 37' 39" W a distance of 118.68 feet; thence S 89° 17' 59" E a distance of 662.88 feet to the Point of Beginning, containing 15.90 acres of land including 1.81 acres of county road right of way.
