

POWER OF ATTORNEY

I, Deborah L. Bergstrom, residing at 716 West Summit, Winterset, Ia. 50273, do hereby appoint Thomas E. Bergstrom, residing at 716 West Summit, Winterset, Iowa 50273, my Attorney-in-fact:

1. To open, maintain or close bank accounts, brokerage accounts, savings and checking accounts or certificates of deposit, or to do any business with any banking or lending institution, in regard to any of my accounts, to make deposits and withdrawals, obtain bank statements, passbooks, drafts, money orders, warrants, certificates or vouchers payable to me by any person, firm, corporation or political entity including the United States of America, and expressly including U.S. Treasury Securities;

2. To prepare, execute and file income and other tax returns, state and federal, and all other governmental reports, applications, requests and documents, and to obtain from the governmental or other entity having custody of them, copies of all such returns or other documents or instruments;

3. To invest, reinvest, exchange or sell any stocks or bonds owned by me.

4. To receive and give acquittance for all sums of money, debts or accounts of any kind which are or shall become due, owing and payable to me;

5. To execute any and all papers, notes, mortgages, waivers, releases or other documents of the ASCS, CCC or other farm programs of the United States;

6. To receive, store, seal, trade, deliver or sell any crop grown on farmland owned by me.

Such Attorney-in-fact shall not be liable for any loss sustained through error of judgment made in good faith, but shall be liable for willful misconduct or breach of good faith

I hereby give to the Attorney-in-Fact appointed hereunder full right, power and authority to do and perform each and every act, deed, matter and thing whatsoever in and about my property, and affairs enumerated above, as fully and effectually to all intents and purposes as I might or could do in my own proper person if personally present; hereby ratifying all that said Attorney-in-fact shall lawfully do or cause to be done by virtue thereof; PROVIDED, HOWEVER, that nothing herein shall give or grant the power to execute a will or change a will.

The wills executed before Jerald Oliver Attorney, Winterset Iowa are to bear, wills of current effect. any wills or testaments executed by David Butler or John Casper are null and void

All reference to property or property rights herein shall include all real, personal or mixed property now or hereafter owned by me.

This Power of Attorney shall be effective 30 of this date and shall not be affected by my disability and shall continue effective until my death; provided, however, that this Power may be revoked by me as to any Attorney-in-Fact at any time by written notice to such Attorney-in-Fact,

however if Thomas E. Bergstrom feels this is not in my best interest, an independent evaluator chosen by court and one chosen by Thomas E. Bergstrom shall examine me and report their findings to a court with appropriate powers to resolve the issue.

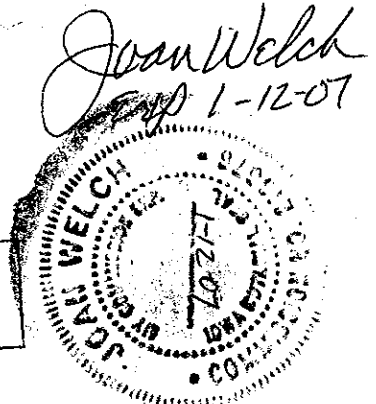
