INTER-AGENCY SHARING AGREEMENT PURSUANT TO IOWA CODE CHAPTER 28E

THIS INTER-AGENCY SHARING AGREEMENT (hereinafter the Agreement) is made and entered into effective July 19, 2005 by and between the City of Van Meter, Iowa, a municipal corporation organized and existing under the laws of the State of Iowa (hereinafter the City), and the Van Meter Community School District, a school district organized and existing under the laws of the State of Iowa (hereafter the District).

- 1. <u>Purpose and Duration</u>. Pursuant to the provisions of Iowa Code chapter 28E (2005), the purpose of this agreement shall be to allow the District to install and utilize a communication radio antenna on the City water tower located south of the District school building for the purpose of facilitating school bus communication to and from the buses and school building and among school buses. The City and District agree that this Agreement shall become effective July 19th, 2005. Either party may terminate this agreement upon 30 days written notice to the other party. Notice of termination shall be sent to the other party's principal place of doing business by registered mail. The effective date of termination shall be thirty days after receipt of the written notice.
- 2. <u>Agreement</u>. The parties agree as follows: Since the City also has installed a radio communication antenna on the water tower, the City and School shall each pay one-half (1/2) of the electrical bill that supports the use of these two antennae.
- 3. <u>Method of Approval</u>. The City and the District shall each approve this Agreement which shall authorize the Mayor and the City Clerk, on behalf of the City, and the School Board President and Board Secretary, on behalf of the District, to execute this Agreement.
- 4. Agreement Recording with County Recorders and Filing with the Secretary of State. The clerk of the City shall cause this amendment to be recorded in the office of the County Recorder in each county in which the School or City are located and filed with the Secretary of State in accordance with the provisions of lowa Code section 28E.8 (2005).
- 5. <u>Governing Law</u>. This Agreement shall be governed by, construed, and enforced in accordance with the laws of the State of Iowa now or hereinafter applicable hereto and shall not be construed to relieve the parties of any obligation opposed upon them by law.
- 6. <u>Entire Agreement</u>. This agreement constitutes the entire Agreement between the City and the District and may not be changed except by an amendment in writing signed by the City and the District.
