Pursuant to the provision of Section 524.1501 of the Code of Iowa, the undersigned state bank adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

The name of the state bank is Security State Bank. The location of its principal place of business is 615 South Division Street, Stuart, Adair County, Iowa.

The effective date of its Renewed, Amended and Substituted Articles of Incorporation was the 21st day of January, 1975.

ARTICLE II

The following amendment to the Articles of Incorporation was adopted by the shareholders of the state bank:

Article I of the Articles of Incorporation is hereby deleted and substituted in lieu thereof is the following:

"Article I. The name of the state bank shall be MetaBank West Central."

ARTICLE III
