

## LEGAL DESCRIPTION:

Parcel "N" in the Southwest Quarter of the Northwest Quarter of Section 24, Township 75 North, Range 26 West of the 5<sup>th</sup> P.M., City of St. Charles, Madison County, lowa more particularly described as follows:

Beginning at a point on the South line of Clanton Street which is 121.29 feet North 89°02'16" West of the Northwest Corner of Block 2, Souder's Addition to the City of St. Charles, Madison County, Iowa; thence South 00°29'32" West 132.00 feet along the West line of existing Parcel "G"; thence North 89°02'16" West 81.66' feet; thence North 00°00'00" East 132.00 feet to the South line of Clanton Street; thence South 89°02'16" East 82.79 feet to the Point of Beginning containing 0.249 acres.

Parcel "P" in the Southwest Quarter of the Northwest Quarter of Section 24, Township 75 North, Range 26 West of the 5<sup>th</sup> P.M., City of St. Charles, Madison County, Iowa more particularly described as follows:

Commencing at a point on the South line of Clanton Street which is 121.29 feet North 89°02'16" West of the Northwest Corner of Block 2, Souder's Addition to the City of St. Charles, Madison County, Iowa; thence South 00°29'32" West 132.00 feet along the West line of existing Parcel "G" to the Point of Beginning; thence continuing South 00°29'32" West 131.89 feet along the West line of existing Parcel "G"; thence North 88°36'22" West 157.02 feet; thence North 89°18'48" West 63.53 feet; thence North 00°00'00" East 131.04 feet; thence South 89°02'16" East 221.66 feet to the Point of Beginning containing 0.666 acres.

## ACCESS & PUBLIC UTILITY EASEMENT TO PARCEL "P."
