





Northwesterly 328.96 feet along a 3819.72 foot radius curve concave Northeasterly with
a 328.86 foot chord bearing North 16°10'25" West; thence North 13°42'23" West 307.69
feet along said centerline to the Point of Beginning containing 10.081 acres including
0.877 acres of County Road right-fo-way.

Commencing at the Northeast Corner of the Northwest Quarter of the Southeast Quarter of Section 8, Township 75 North, Range 27 West of the 5th P.M., Madison County, Iowa; thence South 89°12′23″ West 205.17 feet along the North line of said Northwest Quarter of the Southeast Quarter to the centerline of a county road; thence South 13°42′23″ East 460.00 feet along said centerline to the Point of Beginning; thence North 89°55′11″ East 789.91 feet; thence South 00°17′23″ East 615.00 feet; thence South 89°55′11″ West 628.51 feet to a point on the center line of a county road; thence Northwesterly 328.96 feet along a 3819.72 foot radius curve concave Northeasterly with a 328.86 foot chord bearing North 16°10′25″ West; thence North 13°42′23″ West 307.69 feet along said centerline to the Point of Beginning containing 10.081 acres including 0.877 acres of County Road right-of-way.

WHEREAS the Planning & Zoning Commission of the City of Winterset has reviewed the plat of survey and found that it conforms with the subdivision ordinance of the City of Winterset and that the plat of survey should be approved by the City Council of the City of Winterset, Iowa.
