## SUBORDINATION AGREEMENT

The following agreement is made this October 12, 2005, by and between Paul D. Ferguson and Gayle Ferguson, herein referred to as "Mortgagor", Earlham Savings Bank, herein referred to as "Mortgagee"; and First State Bank Iowa, herein referred to as "Lender".

As an inducement to Lender to grant the loan to Mortgagor, Mortgagee herein does hereby subordinate the above described mortgage in favor of Mortgagee to the loan and mortgage in favor of Lender that is being recorded in Madison County, Iowa currently with this subordination agreement. The parties hereto further declare that the lien of the mortgage in favor of Lender shall be, and is in all respects, a lien prior and superior to the lien of the mortgage in favor of Mortgagee herein, so far as it relates to the above described real estate.

This agreement inures to the benefit of and is binding on all parties hereto and to their successors assigns.
